I. Jacob Strickland of Nash Co, NC married ( ) unknown

A. Elisha Strickland born about 1723 possibly Isle of Wight Co, VA died between 2 May 1795 and Sep 1795 (Franklin Co, NC)

Married (possible Edgecombe Co, NC) unknown

- -She predeceased Elisha possibly in Franklin Co, NC [He <u>did not</u> marry Kinchin Upchurch who was a male. Ten children shown below:
- 1. Jacob (b. abt. 1761 probably in Johnston County NC, died between 1835 and 1840 probably in Gwinnett or Madison Co. GA) married Annie Pearce or Peace 3/16/1783 in Franklin Co, NC. Moved to Anson Co, NC then to Madison Co. GA after 1805, and possibly to Gwinnett Co. GA by 1835; no Madison Co. GA 1810 census exists, and tax records except for 1840 do not survive. Loved on Brushy Creek in Madison County, GA.
- 2. Priscilla (b. about 1765 probably in Johnston County, NC, died between 1801 and 1805), married Jacob Lewis Seagraves (born about 1762 or 1763, died Jun 7, 1835 Clinton Co, Illinois) By 10/21/1800 this family was in Franklin Co. GA; by 1805 Jacob had probably remarried Elizabeth Hanes in GA; by 1810 they were in Rutherford Co. TN; by 1820 they were in Maury Co., TN; by 1829 they were in Clinton Co., Illinois

From court records filed by her brother-in-law Braswell Strickland in Wake Co. NC we know that she was dead by 1805 and left at least six children.

- 3. Isaac (born about 1770, died about 1834 probably in Jasper Co. GA\*) Moved to Jasper Co. GA by 1812. His land was originally in Washington Co., then Baldwin Co., then Randolph Co., then Jasper Co. GA. His land was sold by his Kinchen in January, 1835, so he was probably dead by that time. No will or estate have been found at this time. There is a slight chance he may have moved to Upson Co. GA before his death to be with his children who had moved there.
- 4. Martha Polly (b, 8/19/1771, d. abt. 1846 probably in Franklin Co. NC), m. Braswell Strickland (b. 1/5/1774, d. after 1834 probably in Nash Co. NC)
- 5. Sarah (b. between 1774 and 1778) probably in Wake or Franklin Co., NC died between 1833 and 1834 probably in Franklin Co. NC) m. John D. Pace (b. bet. 1755 and 1774, d. bet. 1818 and 1826)

[Haily Pace (born by 1809) and William (born between 1807 and 1812, died after 1880 who married Martha Helen Amos) may also be sons. William named a son John D. Pace II. He moved from Franklin Co. to Nash Co. after 1850.]

- [The author believes that either James Griffin or Isaac Griffin was Tillmon Griffin who married two of John D. and Sarah (Strickland) Pace's daughters, but no proof has been found.]
- i. unknown female born between 1800 and 1815
- j. Milberry (born between 1810 and 1820, died unknown) married Tillmon Griffin 7/20/1837 in Franklin Co. NC
- 6. unknown male Strickland (born between 1774 and 1790 and died between 1790 and 1795), probable father of Milbry.
- 7. Kinchen (born about 1780/1781, died before 10/8/1863 when his will was probated in Madison Co. GA) Married first Mary (possibly Baker). Married second Sarah H. Branch 3/30/1836 in Madison Co. GA Further research is needed.
- 8. Charity (cannot find dates) married James Johnston (cannot find further info on this family) This family was in GA in 1805.
- 9. Elizabeth (born unknown, died before 1805) married Hardy Griffin before 2/23/1795 (b. between 1770 And 1780, died after 1850) He married 2<sup>nd</sup> Divinity Strickland.
- 10. Ruth (birth and death date unknown but probably dead before June, 1805) marriage info unknown
