Commentary: Parker Upchurch was the son of Hubbard Upchurch and the grandson of Nathan Upchurch I, head of Upchurch Clan Number 3. His biofile reveals he owned land near Upchurch Station in western Wake Co., NC that his father had acquired, as the other sons of Nathan moved three miles east of Green Level. Here we learn of the existence of an Upchurch graveyard not yet located. Note Upchurch connection to the local pioneer families of Holleman and Hudson. Parker was a member of Salem Baptist Church. He died in CSA service having no issue.

(12) Comments on the family of Hubbard Upchurch 1800-1859 RPU 25 FEB 2011 These comments are derived largely from from the will of Hubbard written 31 AUG 1858, probated MAY 1859 and from a deed made by the heirs of Hubbard on 22 NOV1859 both preserved in the Biofile of Hubbard, the deed to RPU by Kenn L. Hicks on 11 FEB 2011 in an email.

The will gives all of his land to son Green Berry Upchurch on condition that he care for his parents for their lives.

Daughter Lorena given non-real estate items to equal gifts already given to his other children not named.

The NOV 1859 deed is not exactly in sync with the will in that it indicates a dower of land has already been set aside by the widow nee Esther Byrd (she died in 1864 leaving a will) and the remainder of the property is in the hands of Hubbard's children who sell their undivided shares to their brother **PARKER UPCHURCH**.

The sellers are styled as follows:

- 1. Armeally (X Her mark) Hudson [Armelia Upchurch] and husband Hinton Hudson.
- 2. Tabbitha (X Her mark) Holleman [Tabitha Esther Upchurch] and husband shown as Willie Holleman but signed as [Wiley W Holleman]
- 3. G.B.U. [Green Berry Upchurch]
- 4. Lindermon (X His mark) Upchurch
- 5. Lorena (X Her mark) Upchurch [Note: Born 1824, still single 1859 Age 35]

Note that the deed does not mention a daughter of Hubbard named Otela Upchurch [Born 1840 presumed died <1859. Note that the deed in the first paragraph mistakenly lists Wiley W. Holleman as W. W. Upchurch. Note that the deed reserves a one acre cemetery where Hubbard rests. Deed land adjoins Levi Baucom, Hinton Hudson, et al, witness George L. Barbee. Hubbard purchased land in 1823, 1834, 1837- how the three tracts relate to the NOV 1859 deed is unknown. It is presumed to lay just SW of Upchurch Station and is probably what is now Upchurch Farms Subdivision. On 18 JUL 1983 RPU and John Lee Upchurch, Jr. walked the tract looking for the cemetery without success.

Proof that Tabitha Esther Upchurch had the middle name "Esther" is lacking. Hubbard had a sister Tabitha and his wife was Esther.

First, that my executrix (hereinafter named) shall provide for my body a decent burial and pay all funeral expenses together with my just debts to whomsoever owing out of the moneys that may first come into her hands as a part or parcel of my estate.

Item 2nd, that I give my soul to God hoping that he will bless and save it for Christ sake.

Item 3rd, that I give and bequeath to my beloved wife, Harriett H. Upchurch and to her heirs to hold and to have in fee simple forever the following property to wit the land upon which I now live together with my right in my mother Esther Upchurch's dower as also all other lands that may be acquired by me that may be a part or parcel of my estate at my death.

Item 4th, I also give to my beloved wife Harriett H. Upchurch and to her heirs all of my stock of horses, cattle, hogs and sheep together with all of my household and kitchen furniture also all of my crop of corn, wheat, oats, potatoes, and fodder with everything that belongs to my estate at my death.

Item 5th, I further will and say that this will shall not be altered by me or any other person without the consent of my beloved wife during my lifetime. [Note: It appears that there could have been a little more to this will but the above is all Erwin Upchurch sent-RPU]
