

Sophia Privett XID-371

Commentary: Sophia Privett (1817 – 1852) was born in North Carolina to Samuel Privett. Both played out their lives in Wayne County, Kentucky, entwined with the George Upchurch clan. Five children of Samuel Prevett married five children of Moses Upchurch, a son of George. Hence there are many details to be understood. The Privette family of Franklin County, NC was closely associated with the Upchurch family there. The relationship between the Privetts of Wayne County, KY and those of Franklin County, NC are yet to be elucidated.
