Rachael and Upchurch had a daughter Barthenia Smith whose life story is quite charming. My guess is that she was named after her grandmother Parthenia Upchurch Smith and that her name could actually have been Parthenia rather than Barthenia. In any case there is the well documented story that a Dr. Thomas H. Avera saw her as a teenager and vowed to marry her, which he later did. Thus was enriched the history of the Eagle Rock Area of Marks Creek Township of Wake County, NC
