*Richard Cotton & B. H. Jones*

are held and firmly bound unto the State of North-Carolina, in the sum of *Five Hundred*  
 Dollars, to be paid to the said State. To which payment:  
 well and truly to be made and done, we bind ourselves, our heirs, executors, administrators, jointly and sever-  
 ally, firmly by these presents, sealed with our seals, and dated this *10th* day of *Nov*, 18\_\_

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That if the above bounden *Robert Rollins*  
 Administra of all and singular the Goods and Chattels, Rights and Credits of *Haywood Lawrence*

deceased, do make or cause to be made a true and perfect inventory of  
 all and singular the Goods and Chattels, Rights and Credits of said deceased, which have or shall come to the  
 hands, knowledge or possession of the said *Robert Rollins*  
 or into the hands or possession of any person for *him*, and the same so made, do exhibit or  
 cause to be exhibited to our said County Court of *Chatham*, within ninety days after the  
 date of these presents, and the same Goods, Chattels, and Credits, and all other Goods, Chattels and Credits of  
 the said deceased at the time of his death, or which at any time hereafter shall come into the hands or posses-  
 sion of the said *Robert Rollins*

or into the hands or possession of any person or persons for *him*, do well and truly administer  
 according to law: And further do make or cause to be made a true and just account of  
 said Administration, within the time required by Act of Assembly, after the date of these presents, and all the  
 rest and residue of the said Goods, Chattels and Credits which shall be found remaining in the hands of, or due  
 from the said Administra<sup>tr</sup> shall deliver and pay unto such person or persons respectively as the same shall  
 become due unto: pursuant to the true intent and meaning of the Act of Assembly in that case made and pro-  
 vided, and in all respects do and perform the trusts and duties of Administra<sup>tr</sup> aforesaid, according to law:  
 And if it shall appear that any Will or Testament was made by the deceased, and the Executor or Executors  
 herein-named do exhibit the same in Court, making a request to have it allowed and approved of accordingly,  
 if the said *Robert Rollins*

above bounden, being thereunto required, do render and deliver the said letters of administration, (approba-  
 tion of such Testament being first had and made in the said Court,) then this obligation to be void: otherwise,  
 to remain in full force and virtue.
