I am sorry that I do not have the working records that Olive Morgan used for her book. We were friends and she would answer my questions but our collaboration was cut short by her death. After a little digging I can now respond to your question. There are many by the name of Moses Upchurch and two of them enter the picture leading to your question. The Moses Family referred to in my transmission of Aug 19 was Moses Upchurch who is Head of one of the 22 Upchurch Clans. His family was in draft mode to be enrolled under the banner of UAFA and I was giving a heads up to his descendants and you are not among them, This information has now been posted on the UAFA website [www.alliedfamilies.com](http://www.alliedfamilies.com) and you can have a look at it if you so desire. This one and two others (Nathan and William, IV) will give you a sense of what enrolled families look like.

We now have in the final stages a draft of material on the family of your ancestor George U. 1757-1830 to enroll in the near future. He is another head of one of the 22 Upchurch clans. The Moses of special interest to you is his son Moses. As soon as The George U. Family has been posted on the website you and all of his descendants recorded in my email address file will be alerted.

Our first posting on the George U. Family will be just a beginning and with inputs and financial support from members of the family we can continue to add large amounts to the narrative and make it a real online history of this family. I hope you will join with us in the effort in one way or another. Individuals who contribute as much as \$50 to support the enrollment of the George U. Family will be listed as a cosponsor for the family. I would welcome your participation now or later.

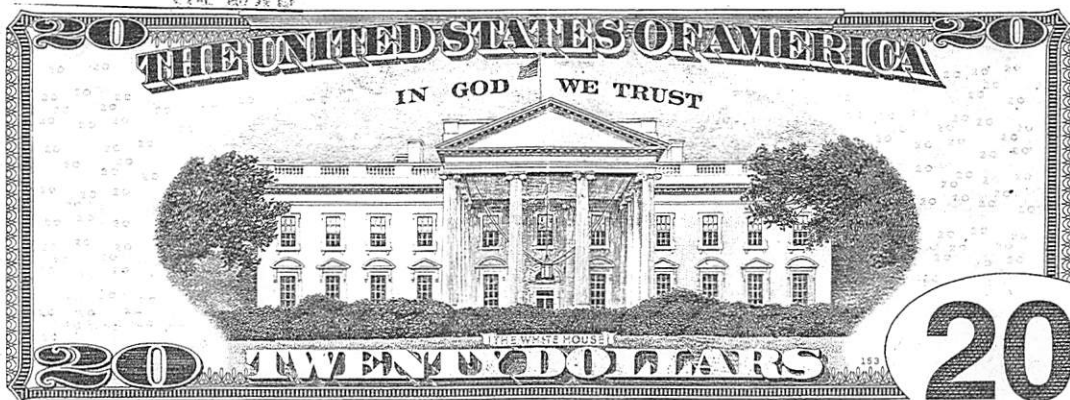

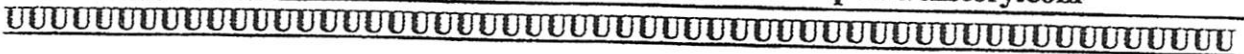
