Dear Cousin Jessie,
Many thanks for your letter of 4 MAR 92 and for your order for UB 92, for your order of one back volume of the UB and for your contribution of \$10.00 to the Upchurch Research Fund. I have elected to send Vol 9 (1988) and it has been mailed. The first issue for 1992 will be mailed this week.

I will be looking forward to the additional materials you plan to send. In the meantime I started to process your letter of 4 MAR 92 and have stopped until I can get more input from you to solve a problem.

Enclosed are copies of my Bifiles on Thomas Gay U, Jr and two of his presumed sons - Mullis J. U, II and William Jefferson U. My problem is illustrated by the 1850 and 1860 census records shown as Entry ⑧ for Thomas Gay U, Sr.

Note that in 1850 TGU, Jr has a son Mullis U age 4 [hence b 1846]. I have assumed this was Mullis J. U who appears as age 11 on the 1860 census (hence b 1849)

However, I am now not so sure these two are the same. My records do not again reveal a Miller U b 1846 although he may be around somewhere. Note that Miller U in the 1850 household is out of order at age 4 being listed later than Robert Gay U age 3 (b 1847). Maybe the simple explanation is that the age 4 on the 1850 census should read age 1. This would fit nicely with Miller J. U appearing as age 11 on the 1860 census - with the ages all in order. Note that entries ③ & ④ on the Miller J. U, II profile are consistent with the existence of a Miller J. U b 1849 (or 1850).

Now comes the question of whether or not your GGF was Miller J. U, II or William Jefferson U. Note for the 1860 Thomas Gay U, Sr household that both sons reflecting these names are present. You show William Jefferson U as b 15 APR 1849 but other records tend to show this birth date belongs to Miller J. U, II and that William Jefferson U was b 17 AUG 1852. Your records show you are descended from William Jefferson U. but the only TX record (see entry ③ - Miller J. U, II) deals with Miller J. U, II and not with William Jefferson U.

Do you have additional evidence showing both
William J. U, II and William Jefferson U in TX
in the 1870-1910 era? I presume everything
you sent about William Jefferson U and his
two wives and his three children is correct
except possibly his birth date.

Note that the 1880 Navarro Co, TX census records
show a Thom U age 4 (b 1876) as a son of William J. U, II.
This is another point of possible comparison. Did
William J. U, II and William Jefferson U both
have sons named Tom b 1875 or 1876? Is
this Thom U on the 1880 census your GF or
do you have your GF located elsewhere on
the 1880 TX census.

I am sure there are records somewhere
to sort out the above matters. I hope you
have these records or can use family letters
or other information to sort out the issues.
