Unlike some of his siblings who moved on to Mississippi, Alison remained in Alabama to help establish a large presence of Abel Upchurch SR descendants in Alabama who continue to enhance the prosperity of the state.

The subject of this notice was born in Greene County, Alabama, March 19th, 1831, and departed this life June 18th, 1891. △[Bartley U XID-590]

When he was five years old his parents moved to Pickens County, where he grew up to manhood. On the 10th of December, 1857, he was happily married to Martha Hickman, daughter of Mr. Wm. P. Hickman. He moved to this county in 1858 where he spent the balance of his life endearing himself to all who knew him best.

He was true honest and pure in his contact with the world. He joined the M. E. Church at Mt. Zion in 1860, giving himself fully and earnestly to the work of the church and consecrating his life to God; always expressing himself as enjoying a full consciousness of His saving grace. For fifteen years the writer has known him intimately; and he feels free to say that he was one of the best men he ever knew. In his death the community has lost one of its best citizens, the masonic fraternity a very bright and zealous mason, the church an earnest and devoted Christian, his family an affectionate husband and father. He almost idolized his wife and children who are now left heartbroken to mourn their loss, but "they sorrow not as those who have no hope." During his last illness of five weeks duration, although he suffered the most excruciating pain he did not murmur, but was fully resigned to the will of his Heavenly Father. His weary body is now at rest and we would not disturb that sweet repose.
