In 1863 the heirs of the late John Pearce petitioned to have his 1125 acres in Franklin Co, NC divided among 9 children. In 1866 the commissioner awarded 187 acres to his daughter Harriet (Pearce) Upchurch and his son in law <u>Ambrose Upchurch</u>.

"My great grandfather Upchurch [<u>Ambrose A Upchurch</u>] was a man who had a speech impediment. Once he told grandfather N D Green – "If you can't, can't say anything good, good don't say anything". Also, once the Baptist Church at Poplar Springs in Franklin Co, NC was having a Saturday business meeting and Upchurch [<u>AAU</u>] had broken a rule of the church. he stood up before the group and said "I'm sorry, sorry and I've always, always been sorry!" My mother [Ella Elizabeth Green – granddaughter of <u>AAU</u>] told me about her grandparents [M/M <u>AAU</u>] she loved to visit them, eat and spend the night with them. A former slave cooked for them. The Upchurches had a large vegetable and lower garden at the back of their home. I have an evergreen shrub that came from a cutting at their home."

His great grandfather was  $\underline{AAU}$  for whom he was the middle name Amos. There is no indication of the source of this detail.

TVP born 1919 is son of Bessie Jane Green, grandson of Elsa Penina --- Upchurch and great grandson of Ambrose Amos Upchurch.

Ambrose Amos Upchurch inherited 120 acres from Burkely Upchurch and got 520 acres from his father in law John Pearce. Ambrose willed their land to two of his sons "Bill" [William Gaston Upchurch] and James Upchurch [James W Upchurch] and they managed it (farmed?) for a couple of years knowing there was a mortgage but then learned there was actually a 2<sup>nd</sup> mortgage They lost the property.

<u>Ambrose Amos Upchurch</u> did have two sons named James Upchurch. The first-born James [born 1852, XID – 647] died at age 19. The second born James [born 1867; XID – 2914] lived to have a family.

<u>Ambrose Amos Upchurch</u> married Harriet Pearce who was the daughter of John Pearce. John Pearce was extremely wealthy and owned 40,000 acres of land and many slaves. He had 6 girls and settled 500 – 600 acres of land on each plus a house and outbuildings and 8 slaves. He had 4 boys and settled about 2,000 acres on each. John Pearce had a large black carriage with servants fore and aft. He and his wife were poisoned by slaves who cooked their food in 1863 at the time Lincoln free the slaves. His grave is in the Moccasin Creek area.

Ambrose Amos Upchurch died Feb 1894, not Jul 1894. He had a fight with his wife and at age 50 went into service in the Civil War.

Ambrose Amos Upchurch named all of his daughters "Ann" hence.

AAU had only twelve children.

<u>AAU</u> was great on hospitality. If someone dropped by he would stop all his work and visit with them and provide food. He was a prominent member of the Baptist Church at Pilot, NC but some members preferred that he not pray as he prayed too long. The church land was given by the Stallings family.

The land near the Upchurch Cemetery at Pilot, NC was land that came from John Pearce, father in law of <u>AAU</u>.

Map shows Mill pond (Note from author: now Bunn Lake), <u>Rocky Branch</u>, Beaverdam Branch, Wolf Pit Branch, Moccasin Creek and roads to Louisburg (Note from author: now Shepard School Road) and Raleigh.

Petition of Virginia N. Gill (mother of three infant children Bertie E., Sylvanus Z. and Alie A. and 2 children of age, who holds life estate in lands in Wake and Franklin Counties, requests partition of the land and requests appointment of a reputable and disinterested person to represent the children as their next friend in the action of partition about to be instituted. Signed Virginia N. Gill before George L. \_\_\_\_\_\_\_ offski, D.C. 8/23/1898. Order that W.T. Smith be appointed next friend of the infants Bertie E., Sylvanus Z. and Alie A. Gill and be authorized to join in the special proceeding for partition. D.H. Young, Clerk Superior court 8/23/1898.

Petition for partition. Filed 8/23/1898 in Book C Partion (sic) p. 368 9/5/1905. Case No. 859. Virginia N. Gill et al. Ex Parte. Stated that her mother had died 12/7/1896 leaving a last will and testament which was admitted to probate in Wake County. All of the real estate of the testatrix was devised to Virginia N. Gill as a life estate and Virginia's children Walter C., James E., Bertie E. Sylvanus Z. and Alie A. are each entitled to 1/5 of the value of the land subject to the life estate of their mother. Walter C. and James E. are over 21 years of age and the other 3 children are minors, Bertie E. being 20 years old, Sylvanus Z. being 18 years old, and Alie A. being 15 years old, all of them living with their mother the petitioner Virginia N. Gill. The land was the property of Mrs. Clara A. Strickland and is described as "All that tract of land lying in Little River Township in the County of Wake and in Dunn Township in the County of Franklin on the waters of Mocasin (sic) Creek, bounded on the North by the lands of Ambrose Upchurch and Benjamin Pearce; on the East by the lands of Joseph Glover and Henry Haywood's heirs; on the South by the lands of Noah Strickland, G.M. Bell and J.R. Edwards and on the West by the lands of Nannie A. Hunter, Lemon Chamblee, Thomas Wiggs and W.H. Chamblee, Jr." A large portion of the land is uncleared and yields a very small income, and it is greatly to the interest of all parties concerned that the land shall be divided before the life estate of the petitioner Virginia N. Gill shall terminate, so that the petitioners who are remaindermen may each own his land in severalty, with the right to improve the same and to render it more productive.

This document concerns a deed made 5 Mar 1870 in Franklin Co, NC. 

However, the plat for the Dec 1865 petition to allocate reveals only 187A x 6 = 1122 acres. 1243 - 1122 - 121 acres missing. Where did they go? Copy of said deed is annexed hereto and marked "A", and made part hereof.

3rd. That prior to the death of Ambrose Upchurch to wit: on the 26th day of June 1878, the said Ambrose Upchurch executed a deed to William Upchurch, by which he attempted to convey to the said William Upchurch a part of his tract of land in Dunn's Township, Franklin County, described as follows: Adjoining the lands of Mary Driver, Bess Pierce and others and bounded as follows viz. in the North by the lands of Mary Driver, on the South by the lands of James Upchurch, on the East by the lands of Mary Massey in the west by the lands of R T Strickland containing One Hundred and Twenty acres more or less. Copy of said deed is annexed hereto, marked "B" and made part hereof.

4th. Both said deeds are of record in the Registry of Franklin County in book 49, page 127 and book 49, page 128 respectively, and were recorded on the 26th day of June 1878 and the 26th day of June 1878 respectively, many years after the execution of the same.

5th. That the grantees in each of the said deeds are the sons of the said grantor, were at the execution of the said deeds, not more than Two and Four years old respectively.

6th. That the said conveyances, while purporting on their face to have been made for a money consideration, were in truth and in fact voluntary conveyances, and no money was then or has ever since been paid by the grantees, therefore.

7th. That at the time of the execution of the said deeds, the grantor,



Ambrose Upchurch, was insolvent, largely indebted beyond his ability to pay and that the deeds were executed with the intent to hinder, delay and defraud the then and all subsequent creditors of the said Ambrose Upchurch.

11th. That upon the death of the said Ambrose Upchurch, and the qualification of his said administrator, it appeared that there were no personal assets nearly sufficient to pay his debts, and the sale of the lands of the intestate in necessitated for that purpose.

12th. That a part of the lands have been, by the grantees, conveyed, or attempted to be conveyed, to J.C. Bunn, who, together with the two sons, James and William, is at present in possession of the whole tract.

13th. That until the death of the said Ambrose Upchurch, he remained in possession of the said lands, was attempted to be conveyed by himself, exercising acts of ownership over said lands all his life, and that the said conveyances were cautious and fraudulent, intended to hinder, delay and defraud the then and subsequent creditors of the said Ambrose Upchurch of the collection of their debts. Wherefore the plaintiffs beg judgment.

I. That said deeds be set aside and avoided.

That on the second day of July 1894, Ambrose Upchurch died in the County of Franklin, in the State of North Carolina, intestate, and that shortly thereafter, to-wit: on the ....day of July 1894, William Upchurch qualified as his administrator, and entered into bond payable to the state of North Carolina, with the other defendants as sureties thereto, in the sum of Four Hundred dollars, with the usual requirements and conditions of such bonds. (A copy of which said bond will be offered in evidence, in this case when in its progress it may become necessary.)

SECOND. That as such administrator, there came into his hands personal property and effects belonging to the estate of the said Ambrose Upchurch, in the sum and amount of \$299.41, which said personal property and effects, after the payment of the debts of the estate, was distributable to the plaintiffs above named. THIRD. That the said defendant administrator had not at any time since the coming into possession of the said personal property and the said monies and chattels aforesaid, filed any inventory or made any account, showing in what manner he has disposed of said property or how he has applied the same although more than 2 years have elapsed since the grant of letters of administration ... FOURTH. That the estate of Ambrose Upchurch was indebted if any at all, in a very small amount, and the defendant administrator, while not paying any of the debts of the estate, small and inconsiderable as they were, has not paid over to these distributees any part of the monies so received by him, to which they were properly entitled, but has eloined and appropriated the same to his own use, in utter disregard of the requirements and conditions of the said bond, and the plaintiffs' rights herein.

FIFTH. That these plaintiffs are advised, that by so eloining the said moneys and chattels of the intestate's estate and appropriating them to his own use, by filing to make his inventories and account, as by the law required, and by other like acts of omission and commission, the said defendant administrator has violated the conditions of his said bond, and rendered himself and sureties liable thereon.


