James Goodwin was born 1784 at Wake County the son of William Goodwin In and Winifred Throatball. He married Jamey (Genes) Holland at Wake County N. C. on October 7, 1807.

Gense Holland was the daughter of Sampson Holland and some born in 1786 at Chatham County. In died about 1828 at Chatham County.

They had seem known children. (1) Rhedrick Coolwin was born August 28, 1809 at Wake County, N. C. Ho married (1d) Gilla (---) in 1837 at Chatham County. Ho married next Clienboth (Bettie) Danie on January 15, 1859 at

Chatham County. (2) Milly Coodwin was born on August 12, 1811 at Wake County, N.C. She married Stephen Wilson at N.C. Stephen was been in 1809 at Chatham and died in 1870 at Chatham, North Carolina. Milly died on March 2, 1877 at Wake County. (3) Rebeau Goodwin was been on December 27, 1814 at Wake County N. C. See married William Cotton about 1835 at Chalham. She was living with has daughter, Indeell, in the 1880 Consus. (4) Caloin Goodwin was born on April 30, 1817 at Chatham County, N. C. He married (tst) Sally Ann Catter on November 13, 1889 at Chatham County. He married (2nd) Gustie Ann Upcharch on Normalur 21, 1869 at Chatham County. (5) Joseph L. Geodwin was born on June 15, 1820 at Chatham County N. C. He was an Overseen for William Belin of Raleigh at Vanor, Missiarippi in 1860. He varved to Penry Georgia where he died about March 1861. James gave "Power Of Attorney to Henry Lacklee to get what is due James from his son's estate and the proceeds to be divided equally among James's children. (6) John Wesley Goodwin was born on September 15, 1822 at

, Chatham County. He died about 1878 in Chatham County. He married Mary Jame Williams about 1844 in Chatham County. (7) Jama Ruffin, was born Jane 20, 1825 at

Chatham County. He died between October 18, 1897 and March 23 1900 at Wake County. He married (1) Cynthia Boling on March 20, 1877. He married (2nd) Marry Ann Boling on Jam 5, 1862 at Chatham County.

James married for a record time. He married Phonabe Laurence on December 13, 1828, at Chatham County. Thereshe was born in 1862, at North Carolina. There were six known children. Providey died in early 1869. Her will dated August 28, 1868 was probated on March 5, 1872. The children am listed as follows: (1) Alford Gradwin was born on October 7, 1829. He died in June 1892 at Chatham County, He married (1) Louisa Eabanks in 1860 at Chatham County. He namied (x^4) Morths J. Smith on November 25, 1886 at Chatharr County. (2) John Goodwin was been on January 10, 1831, at Chatham County. He died on February 8, 1865. He married Lacy Ann Vick on October 20, 1855 at Chatham County. (3) Susan Goodwin was born in October 23, 1832 at Chatham County, She died on July 21, 1922 at Wake County. See married H. C. Lashly on February 12, 1851 at Chathaus County. (4) Gastan Goodwin (untersoud) was born on June 18, 1835 at Chatham County. He died in 1902 at Chatham County. He manned Sarah A. Horton. He was the only

child named in James' will to receive property. Gaston and his sister Mary were named in Pheribee's will as beneficiaries of her estate. (5) Nancy Goodwin (untraced) was born July 2, 1837, at Chatham County. (6) Mary Jane Goodwin was born on November 4, 1842, at Chatham County, North Carolina. She died on December 30, 1921 at Chatham County. She married Benjamine Franklin Upchurch in 1875 at Chatham County. She was named as a beneficiary in Pheribee's will. James died on March 17, 1861 at Chatham County, North Carolina.
