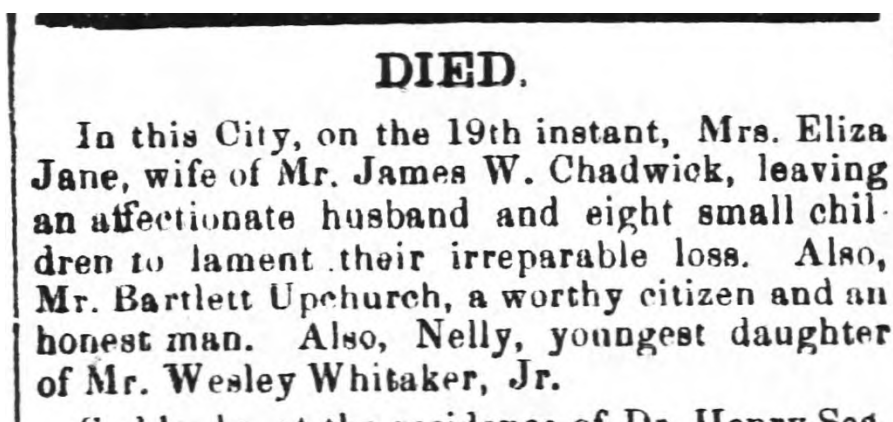


Bartlett Upchurch XID 588

Commentary: Bartlett was the son of Burtis, and the grandson of Nathan, the head of Upchurch clan 3. He married Rebecca Jane Whitaker in 1842.

- (1) Bartlett Upchurch was the son of Burtis (1781 – 1840) and Margaret Yates Upchurch (18)
- (2) Notes copies from Ad Morgan 10 Jul 1975 “census cards 1850 – Wake County NC – Bartlett (son of Burtis) d 21 Jun 1855.
- (3) According to the Raleigh Register Newspaper of 27 Jun 1855, Bartlett Upchurch died 19 June 1855 (1)



- (4) Attachment #16, West letter 18 May 1975 – quotes same source, but was spelling Bartlet.
- (5) Per attachment #18, West letter 18 May 1975 – Wake County NC deeds to U’s
 - a. “23 Jun 1841 – Bartlett Upchurch bought land”
 - b. “14 Jul 1845 – “ “– 2 tracts”
 - c. “6 Jun 1855 – “ “
- (6) Bartlett Upchurch married Jane Whitaker 27 Dec 1842 per Raleigh Register Newspaper 30 Dec 1842 (1) [Carrie L Broughton show md “in” Raleigh]
- (7) Attachment #16, West letter 18 May 198=75 quotes same source as in (6) but was spelling Bartlet.
- (8) Attachment #14, Elva E Burkhalter letter 2 Feb 1978 confirms above (6) and (7) and spelling Bartlett, but specifies Raleigh (as place of marriage? – RPU)

“Corina M Upchurch and John R. Williams 24 Feb 1868” Note of West indicates Corina M Upchurch is daughter of Bartlett and Rebecca J Upchurch.

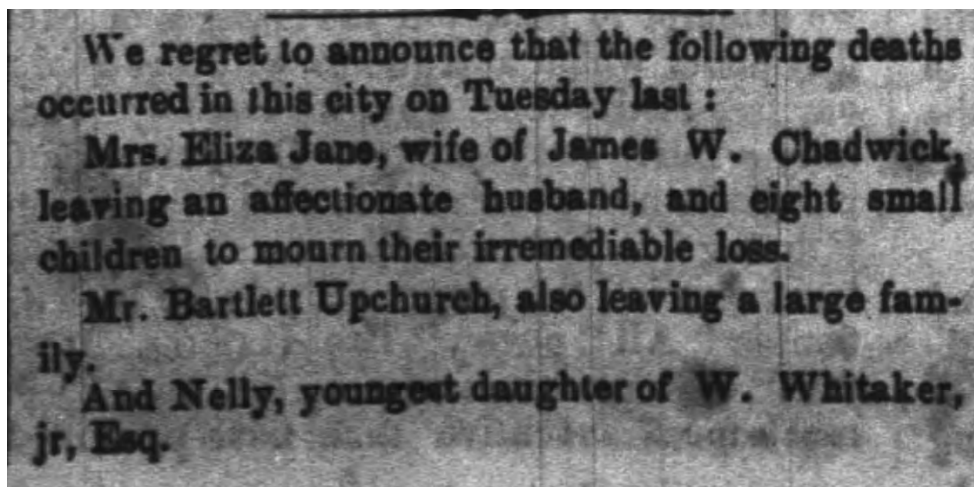

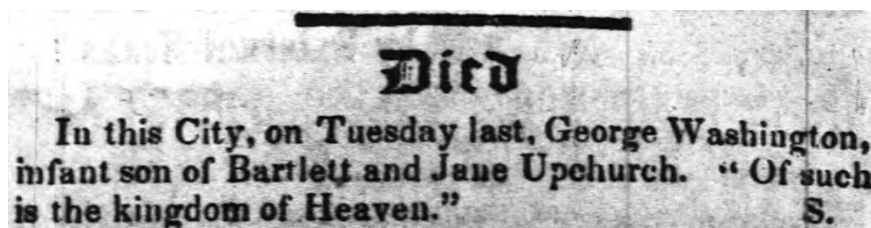
