Commentary: Cara Michael Upchurch was a daughter of Ruffin and a granddaughter of Moses Upchurch, head of UAFA Clan #1. She was born in 1846 and died in 1928. Her husband, William Scott and she raised five children in the Wake and Chatham Counties of North Carolina.

The parentage of JOHN SCOTT of Wake County, N. C., who was the ancestor of the line of SCOTTS in which this writer is interested, has not been proven. However, in 1762 one JOHN SCOTT of Wake Co., N. C., was buying and selling land on Crabtree and Walnut Creeks. He left a will, recorded on the first of November, 1819 (WAKE CO., N. C. WILL BK. 15/347), naming his wife, Hannah and children, without naming his children. Presumably JOHN SCOTT who was later active in land deals in this same section was one of those unnamed children.

[Note: So he could not have been the father of the children of CMU born later – RPU]
