

Abstracted by Fred Turner

This roll contains information from pensions issued to Confederate Civil War soldiers and their widows. The excerpt given here is taken from the first pension listing on the roll; however, the entire roster goes through 1923. This will show the reader an example of what can be found and researched in the Olivia Raney History Library.

On the Soldiers' portion of the roster three classes are shown; 2nd, 3rd and 4th. These classes pertain to grades assigned to veterans based on type and severity of wounds. Grade 1 (of which none are listed) was for totally disabled pensioners; Grade 2 was for pensioners who lost an arm or leg: Grade 3 was for pensioners who lost a hand or foot; Grade 4 was for pensioners who lost an eye or were partially incapacitated due to other wounds (information on Grades were found in *Guide to Research Materials in the North Carolina State Archives: State Agency Records*, page 654).

Another note is that many times a witness is shown as V Royster D/C. This individual was Vitruvius Royster, chief deputy clerk of the Wake County Superior Court (information found in the Raleigh, NC City Directory 1911-12).


