Commentary: Gilbert was the son of Nathan and Agatha Butler Upchurch. Nathan was the head of Upchurch clan 3. Gilbert's family had more than its share of tragedies. Blindness and insanity struck this family with cruel intensity. This biofile discusses these cases and suggest reasons for this calamity.

(no number) Was blindness among the descendants of Nathan Upchurch, I related to the cases to the cases of insanity in the family. (See RPU Extract 29 Nov 2011) – RPU 30 Nov 2011.

By reference to the 29 Nov 2011 Extract sheet it will be seen that the insanity / blindness cases all involved descendants of Nathan's son **Gilbert Upchurch**.

<u>Gilbert</u>'s son Nathaniel Smith Upchurch had two sons and one granddaughter declared insane (Susie).

Susie was also a granddaughter of <u>Gilbert</u>'s son William George Upchurch (due to intermarriages in the family.)

[In the Extract I explain how these cases of insanity could have been the "luck of the draw" and how modern medicine might have made unnecessary the pejorative term "insanity". However, in the case of Susie, one cannot overlook the two close marriages of four of her ancestors (two couples). Susie and her full siblings did not show robust health records.]

The blindness involved the other sons of <u>Gilbert</u> – Bartley, Lamberth, and Mariah. The latter two were blind (completely or partially?) (from birth?). My unsubstantiated guess has always been that the blindness of these two could have traced to venerial disease introduced by <u>Gilbert</u> as he had some known weakness of character. These two children had different mothers.

Bartley had a great-granddaughter, Frances Holt Tilly who developed complete blindness as an adult. Her years of explaining her condition led her to believe that her blindness was hereditary and thus connected to that of Lamberth and Mariah.

In conclusion, I have developed no connection that the insanity or blindness cases are genetic in nature or that they are related. Others with more expertise may show genetic causes.

B. "Nathan had several boys one of which was named Gilbert – born in 1792 died 1845. Gilbert was our grandfather. He had five girls (3 died with TB and one burned up.) He had five boys also. Gilbert married Lucretia Mills."

WAM speculates that **Gilbert Upchurch** did in fact marry Elizabeth Upchurch in 1816 and that she died and that Gilbert Upchurch then commenced a relationship with Lucretia Mills which became a husband/wife relationship either through marriage or by common law.

I am also always looking out for further information about Gilbert's "Elizabeth." Because of the July 1820 birth date of Mariah Elizabeth, I'm now guessing that this first (?) child of Gilbert and Lucretia was actually born to Elizabeth. I'm also guessing that the mysterious child named "Marie" was the same as "Mariah Elizabeth."

RPU Comments re above. All known information fits the above proposal that Mariah Elizabeth Upchurch was a child of <u>Gilbert Upchurch</u> and his first wife Elizabeth Upchurch whom he married in 1819. However, I know of no rationale for the proposal that Mariah Elizabeth Upchurch and Marie Upchurch were the same. Uncle Gettys told me <u>Gilbert Upchurch</u> had 5 daughters. Sister Perry [Leora Perry] told me one of the 5 was named Marie. Sister Perry knew enough not to confuse Marie and Mariah – RPU – 11 Apr 2001.

Lucretia Mills

Lucretia Mills, daughter of Naaman Mills and --- ---, was born 3 May 1802 in Edgecombe Co, NC and died 26 Sep 1877. She married after May 1823 <u>Gilbert Upchurch</u> (born circa 1792, died circa 1845), son of Nathan Upchurch and Mackey Johnson. For more info see ch. <u>Court Dates Etched in Time</u> (May 1823 – page 51).



Lucretia is buried at Inwood Baptist Church Cemetery, Wake Co, NC = gravesite marked with tombstone. A memorial tombstone is also placed there for **Gilbert** – his actual burial site is not currently known.

On FC/1830 Lucretia and her children fit the description of Naaman Mills' household in Wake Co, NC. On FC.1840, **Gilbert** is listed as head of a household in Wake Co, NC.

After <u>Gilbert</u>'s death, Lucretia and her family resided in Wake Co, NC (White Oak Township) on FC.1850-1860. In 1860, Lucretia owned real estate valued at \$72 and a personal estate valued at \$200. Lucretia resided in Wake Co, NC (Barton's Creek Township) with her son, Bartley and family on FC/1870. Lucretia lived to age 75.

Allegedly, Naaman Mills' Bible was passed down to <u>Gilbert</u> and Lucretia's descendants. According to various writing: "Lucretia's family started to move to Tennessee in 1812, but they stopped in Green Level, NC and bought a farm and settled there. She had five brothers and was the only girl. Her brothers were all farmers – very honorable people, but never rich. Her father was Naaman Mills. We have his Bible, which was printed in 1769."

The balance of this chapter will list the children and descendants of Lucretia Mills and <u>Gilbert Upchurch</u>. Note: The first child, Mariah may not have been Lucretia's child. The ten children:

This entry was discovered 23 Sep 1993 while the author was reading the original Wake Co., NC CPQS minutes at the NC State Archives. Until this document was found, no one had successfully became a member of the Daughters of the American Revolution (D.A.R.) under Naaman Mills' lineage. He is now listed in the D.A.R. PATRIOT INDEX.

Naaman's wife died between 1810 and 1830. It is not known if she was alive when Naaman and his family moved to Wake Co., NC about 1812. Perhaps she may have died about 1811 and this is what triggered Naaman to move away from Edgecombe Co., NC.

Naaman Mills and his wife had at least 10 children and 51 grand children. During 1996, eight generations of Naaman's descendants number well into the thousands — many of them are listed in this book.

[Note: It is not clear to me if this was a child yet to be born as of May 1823 – or if the child had been born earlier = say in 1820. Since Gilbert had to pay £5 for lying in and court costs and £5/ year for 5 years. I reported on my update for Nathaniel Smith Upchurch and on health issues going back to his father Gilbert Upchurch of sanity and eyesight we concentrated on eyesight.

Frances Holt said she had 5 issues with her eyes and once thought the issue traced to Gilbert Upchurch as he had 3 blind children. However, she now concludes that , if genetic, her main issue traces to her father Holt Tilley. She says Holt had severe night vision problems.

Frances Holt cited the descendants of Bartley Jefferson Upchurch that had eyesight issues. However, as she cited them I came to feel they were the same kinds of problems that normally occur in the general population.


