John Dudney was born 31 Jul 1824 in Montgomery County, NC and died 11 Mar 1857 in Stanley County, NC. He married Elizabeth Adeline Shoffner in 1844 and from this union 5 children would be born.

Page 3 Odie Marie Upchurch (Great-Granddaughter of <u>John Dudley Upchurch</u> and mother of Jeanene Standfer ??) states "my great-grandmother, Elizabeth Adeline (Schoffner) Upchurch left North Carolina sometime during the early 1970s and came to Red River Co., TX. Her husband, <u>John Dudley Upchurch</u> and son William had died previously in NC.

  Eliza A. Shoffner born around 1808; Married James Upchurch around 1850, Stanly Co., NC son of Allen and Mary Upchurch. Eliza's husband died around 1857 and left her a widow with four little boys. In the 1870's, Eliza and her children went West with her brother, Martin Shoffner. They went to Arkansas where they stayed a short while. Two of Eliza's sons, James and Robert, married Arkansas girls, and another son, William, possibly married and is buried in Bodcaw, AR. Later Eliza moved across the border into Texas with her brother, Martin. The US Census of 1880 shows Eliza and 3 of her children living in Red River Co., TX, near her brother Martin. Many of her descendents live in the Dallas and Ft. Worth TX area. Four children all born in Stanly Co., NC.
  - Martin A. Upchurch born around 1851, married Amanda A. L. Russell, Nov 23, 1875. Red River Co., TX born around 1855 in NC one child [transcriber unable to read remainder of text in this line – VAS 12 Feb 2021]
  - 2. James A. Upchurch, born around 1852, married Mary \_\_\_\_\_ born around 1855 in AR.
  - 3. William J. Upchurch born around 1854 probably married and had at least one son named William and also a grandson names Will. Died in 1886 in Bodcaw, AR
  - 4. Robert Upchurch born around 1856, married Martha born around 1860 in AR
- 5. In 1880, Eliza was living in the home of A. M. ??? and wife J. C. ??? as a "boarder". \*[Note: This appears to be a major error in this document on all other evidence seems to point to Eliza having not married James Upchurch XID-4432 but rather his brother **John Dudney**

Upchurch for and in consideration of the sum o- one Dollar in hand paid by the said Benjamin Upchurch the receipt whereof is hereby acknowledged and for diverse other consideration hereinafter mentioned do bargain, sell & convey & confirm unto the said Benjamin Upchurch his heirs or assigns the following property to wit: - One mule one Bay mare, one 2 horse wagon, & harness, Eighteen head of hogs one hundred & fifty bushels of corn, Twenty bushels of wheat, two thousand pounds of seed cotton, all they ay, fodder, shuck & straw, that I now have, three head of cattle, one clock, one stand of Bees And whereas I the said Jas A Upchurch am indebted in the



following sums to wit one judgement due to the said Benjamin Upchurch for twenty five Dollars, one ditto to same for twenty five Dollars both dated 13th of Augt 1857 one bearing int from 3rd of December 1856 with 40 o costs the other bearing Int. from the 10<sup>th</sup> Febry 1857, with 40 cents cost, two Judgement to J. O. Rose, one fifty Dollars with Int & cost, the other for about Seventeen Dollars with Int & cost, the execution on the first names fifty dollars Judgement, stayed by the said Benjamin Upchurch, one note made to Martin Shoffner, Admr. Of **Jno. D. Upchurch** for Twenty Seven Dollars & thereabouts, dated sometime in August 1857. & due on day after date with the said Benjamin Upchurch as security one note to A. J. Dargan for ten Dollars dated in August 1859. & due on day after date with Benjamin Upchurch for security & one note to Jas. L. Gaines, dated & due as above with the said B Upchurch as security & whereas the said Jas A. Upchurch being desirous to secure the payment of aforesaid debts, now therefore to the full meaning and intent of these premises, I the said Jas A Upchurch do hereby warrant & defend theright and title of the aforesaid property to the said Benjamin Upchurch in Trust for the payment of the aforesaid debts until the 1<sup>st</sup> day of November 1858 at and after which time should the aforesaid debts or any part thereof remain unpaid then the said Be. Upchurch to advertise according to Law and sell on the premises of the said Jas. A Upchurch, all the above mentioned property or so much thereof as shall be of value sufficient to pay the aforesaid debts or such part or parts of them as shall remain unpaid together with all the costs & expenses incident hereto the said Benjamin Upchurch being thereunto moved at his own discretion.
