Commentary: John Upchurch V born about 1774, died 1854 Henry County, TN, was the son of William Upchurch IV, head of Upchurch Clan # 9. His biofile is rich in details that hel us to define the William Upchurch IV family. He would have been a teenager when his father died in Wilkes County, NC in 1787. He, along with other members of his family, migrated to Greenville County, SC from which they may have had a brief stop elsewhere before moving on to Henry County, TN. There he lived out the remainder of his dys. The bulk of the Upchurches in Henry County, TN trace back to John, but there are exceptions. When the definitive story of the William Upchurch IV family is written the contents of this Biofile will be rich source of information.



I wrote to a Mrs. Avlyn Dodd Conley, who works on the Darnell Family.

I also asked her about the Celia Darnal (b.12 June 1784;d 27 Apr. 1852) buried in the Upchurch Cemetery in Henry Co, TN. About Celia, she said that she was the wife of Nicholas Darnall, Sr. (father of Thomas L. Darnell (6241) and had been named as said wife in Nicholas' will.

"Celia Darnell will. To Mary Jane Aycock (formerly Mary Jane Upchurch) to have negro girl. To Celia Elizabeth Wynns (formerly C.E.Upchurch) to have negro. To Bayliss House Upchurch have negro. To John F (not 21 years of age) and George W. Upchurch to have negroes. To Eli Upchurch a negro girl. To Jeanette Darnell for life certain property. Appoints Thomas J. Wynns and Jordan T. Aycock executors. 10 May 1848 (wills 1844-56, p.433) Henry County, TN

This seems to indicate that Celia Darnell was closer to the Upchurches than just a mother-in-law of Jeanette Darnell. In fact, it seems to say that she was closer to the Upchurch side of the family than to the children of her husband who are not even mentioned in her will.

All of the Upchurches listed in her will are (purportedly) children of Joshua Upchurch and Jeanette---although I sure wish I could find proof of that in the case of Celia Elizabeth Upchurch who married Thomas Jefferson Wynns (which is one of my lines). JOHN UPCHURCH's will (dated 1853, probated 1854) names four sons of his deceased son Joshua, as John, Bayless, George and Eli, which is the same 4 males as in Celia Darnell's will (who died in 1852). JOHN'S will further says "and the five remaining heirs of my son Joshua Upchurch dec'd". Does this mean that there were only 5 still alive or that there were 5 more besides the ones that he'd named?

In 1850, Jeanette Upchurch Darnell, John F., Bayliss, G.W. and Eli Upchurch were in household of Thomas L. Darnell as was Celia Darnell <Household #115-Dist. #16>. Celia Upchurch Wynns was in household of Thomas Jefferson Wynns (with a 6 month old girl named Jennette) <household #116-Dist. #16>. Mary Jane was in household of Jordan T. Aycock <Household #58-Dist.#1>

In 1860, I find in D#1856, Jennetta Darnell and George Upchurch; D#1969 John F. Upchurch and his family; D#1950, Bayliss Upchurch and his family; D#1833, Celia E, Wynns in household of Thomas J. Wynns-don't find Eli Upchurch or Mary Jane and Jordan Aycock.

I guess Mary Jane could have died after the writing of Celia's will and before JOHN's will. Making Celia, john, Bayless, Eli and George the five remaining children of Joshua. I guess the first thing I need to do is see if I can get a copy of a will for Joshua. Then be on the lookout for a marriage between Nicholas Darnell and Celia which may give me a clue as to who Jennette, is.

Avlyn Conley indicated that the Darnell family had been in Marshall County, KY earlier.

The slots in the David Upchurch household are imperfectly accounted for by known family records. Names are needed for 1 male and 3 females, children of David born 1800- 1810.

A slot in the David Upchurch household for a male born 1784-1794 (age 16-26) could be for William Upchurch, a brother of John and David.

Some years ago Sarah Ann Upchurch was penciled in as a possible daughter of **JOHN UPCHURCH**, V-source unknown.

Page 2 was created on 14 April 2013 in an attempt to find slots for known/presumed children of **JOHN UPCHURCH**, V. A slot on the 1830 Census was at first assigned to Sarah Ann Upchurch, but now I conclude that that slot belongs to daughter Ariel Upchurch 1821-1839.

There are two available slots for 2 daughters of <u>JOHN UPCHURCH</u>, V on the 1810 Census of Warren County, KY; one of these could be for a daughter Sarah Ann Upchurch. They are:

A female 10-15 (b1795-1800) The array shows a place for a daughter born about 1798 but note this slot is not present on the 1810 Census?

One of the four females age 0-10 (born 1800-1810) on the 1810 Census.

We do not know of <u>JOHN UPCHURCH</u>, V had a daughter named Sarah Ann Upchurch but the name did surface in later generations, probably based on an earlier Sarah Ann Upchurch who could have been a daughter of <u>JOHN UPCHURCH</u>, V.

- p 339: February term 1845 John Upchurch administrator of all and singular goods and chattels, rights and credits of Jerry Upchurch, decd, this day appeared in open court and returned and inventory and an account of all of the Estate of said deceased which was received and ordered to be recorded.
- p 352: May Term 1845 Ordered by the court that John Kendall, Thomas L. Darnold, and John Upchurch be appointed commissioners to lay off and set apart one year's provisions to Mariah Ruple (?Russell?), widow and relict of Mathew Ruple (?Russell?), deceased, out of the Estate of said decease and make their report to the next term of this court.
- p 543: September Court 1848 Ordered by the Court that the following named persons be appointed Judges and inspectors of the election for electors to vote for President of the United States to be held in November next at the different precincts in Henry County to wit: . . . In District No. 4, Robert Aycock, Melton Wakeland and John Upchurch

John Upchurch's will is recorded in the Henry County, Tennessee, Will Books, Volume G-H, for December 1844 - January 1863 on pages 619-621. It was dated dated 30 April 1853 and probated in the November court tern in 1854. It includes (quoted):

- To son, Jesse Upchurch negros Johnson and Drucilla, one bed, bedstead and furniture and \$200 before a division is made
- To 4 sons of Joshua decd, John, Bayliss, George, and Eli negro Ovil
- To 3 sons of dau Catherine Darnell, William, Jesse, and Thomas L. all
- land south of Beaver Creek Dam except 20 acres on the north end of the tract of 30 acres and also the M. Campbell tract consisting of 180 acres and also the negro man named Doctor, and to my grandaughter Sarah Jane Yancy \$50 out of the sale of my private property
- To son David Upchurch 3 negroes, one girl named Harriett and two boys Foster and General, and also all the Darnell tract of land except 20 acres in the south west corner of the tract
- To heirs of son James Jackson Upchurch home tract of land, and 20 acres off of the northwest end of the tract of 30 acres lying on the south side of Beverdam Creek and also 20 acres off of the southwest corner of the Darnell tract, negro boy Isaac (?) to be equally divided between all of the heirs when the youngest becomes of age but to be cultivated and used until that time by the said James J. Upchurch for his and his families support
- To negro woman Sophia her freedom after my death, to live with one
- of my sons Jesse or David as she may choose, a wheel, cards, and loom
- All other property not specified to be sold and the \$200 paid to my son
- Jesse Upchurch, the balance to be divided between my two sons Jesse and David and the five living heirs of son Joshua, decd, in three equal portions.

John Upchurch was married about 1799 in Greenville County, South Carolina, to Elizabeth "Betsy" Hawkins, daughter of William Eaton Hawkins (see Hawkins Lineages). Elizabeth was born in 1776 in North Carolina, died 19 December 1852 in Henry County, Tennessee, and was buried in the Hughes Cemetery. Her gravestone reads: "Elizabeth Upchurch departed this life Dec. 19, 1852 aged 80 years." Elizabeth was enumerated as a widow, head of household, age 74 years in the 1850 Henry County, Tennessee census.

John and Elizabeth "Betsy" Upchurch had seven known children:

- Joshua Upchurch (Generation 11)
- John Upchurch was born about 1801 in Greenville County, South Carolina.
- Jesse Upchurch was born 23 May 1892 in Greenville County, South Carolina, died 10 August 1875 in Henry County, Tennessee, and was there buried in the Hughes Cemetery. He was enumerated as head of household in the 1830-1870 Henry County, Tennessee, census records. Jesse Upchurch served as a juror in August 1845 for the State v. Joseph H. Dillahunty Bastarday. Jesse was first married to Delana "Dilly" Butts, who was born 29 August 1803 and died 24 February 1866. He was married second 12 June 1869 to Martha Susan Jackson. Jesse and Delana had five known children: Elizabeth Upchurch, Katherine Upchurch, Zenobie Upchurch, Julie Upchurch, and Frances Upchurch.
 - Catherine Upchurch died before 05 March 1848. She was married to Thomas L. Darnell.
 Thomas L. and Catherine (Upchurch) Darnell had one known child: Thomas Darnell.
- David Upchurch was born 10 September 1809 in Kentucky, died 13 January 1871 in Henry County, Tennessee, and was buried there in the Hughes Cemetery. David was enumerated as head of household in the 1830 through 1870 census records for Henry County, Tennessee. Reference his Fan=mily Bible under John² Upchurch. His will, recorded in the Henry County, Tennessee, Will Book J-L, August 1865-March 1879, was dated 15 September 1861 and probated in the February term in 1871. An inventory of his estate was recorded in the same book on 21 February 1871. David Upchurch was married to Nancy Marina Tayloe, who was born 02 May 1815 and died 05 March 1874. David and Nancy had twelve known children: Nancy Caroline Upchurch, Elizabeth Joanna Upchurch, Francis Marion Upchurch, Maryland Ariel Upchurch, Mariah Ann Upchurch, James Franklin Upchurch, John Tayloe Upchurch, Mary Catherine Upchurch, Marina Genette Upchurch, Martha Jane Upchurch, Melvina Emeline Upchurch, and Thomas Jefferson Upchurch.

- James Jackson "Jack" Upchurch was born 06 January 1813 in Kentucky, died 01 April 1858 in Henry County, Tennessee, and was buried there in the Easley Cemetery. He was enumerated as head of household in the Henry County, Tennessee, census records from 1830 through 1850 and was listed in the Family Bible of his brother, David Upchurch. James was married 03 April 1842 in Henry County, Tennessee, to Karen/Caron Habbukak Rumley, daughter of T. and R. Rumley. Karen was born 20 November 1822, died 10 December 1860 in Henry County, Tennessee, and was buried there in the Easley Cemetery. James and Karen had four known children: Tobe Upchurch, Buck Upchurch, Angelyn Upchurch, and George Upchurch.
 - Ariel Upchurch was born about 1823 in Tennessee and died about 1840 at age 18 in Tennessee.

This extract draws from emails 4 and 11 MAY 2011 from Richard Holt to RPU and concerns a Sarah Ann Upchurch of Henry County, TN who married a brother of Richard Holt's ancestor Elizabeth (Frazier) West. [Sarah Ann Upchurch is a presumed daughter of David Upchurch and granddaughter of William Upchurch, IV Head of Clan-RPU]

I. Thomas Frazier, Sr. 1759-1844 was a Revolutionary War Veteran who lived in Sampson County, North Carolina also resided in Cumberland and Johnston Counties, NC. He married Elizabeth Fowler. Their oldest son Thomas Frazier, Jr. moved to Henry County, TN prior to 1824 and encountered Upchurches. In 1826 Thomas Frazier, Sr. moved to Henry County, TN to be near Thomas Frazier, Jr. and brought his younger children including Daniel Frazier. After Thomas Frazier, Jr. died (<5 SEP 1836) and before the 1840 Census Thomas Frazier, Sr. moved to Gibson, County, TN* where he died in 1844.

A. Thomas Frazier, Jr. born__; died <5 SEP 1836) per a court record**-Henry County, TN court number Book A (1824-29) page 54; 30 JUN 1824 moved to Henry County, TN before 1824. Married () Jane Autry. She became a Mormon and moved from Henry County, TN to IL after 7 MAY 1844. She joined the Mormon Trek to UT with several of her sons

[Note: Sarah Ann Upchurch is presumed to daughter of David Upchurch and granddaughter of William Upchurch IV, Head of Clan-RPU]

*More Re: Gibson County, TN: Elizabeth (Fowler) Frazier lived there, as did a daughter who previously lived in Henry County, TN. Three brothers of Elizabeth are Hardy Fowler, Beamon Fowler, and Samuel Fowler.

** More Details from this Court Record: this 1824 court record shows that "hands "of the following people are to work on roads under the directory of John Lee: Etherlred Elinor, Benjamin Elinor, John Swor, Thomas Frazier, Jr., (Raiford Cooper, and William Ross)-Brother in Law of Joshua Upchurch and John Upchurch, Jr. = (sons of <u>JOHN</u> <u>UPCHURCH</u>, V and grandson of William Upchurch, IV-Head of Clan) Ambrose Upchurch son of David Upchurch and grandson of William Upchurch IV. This Ambrose Upchurch and Sarah Ann Upchurch are siblings RPU.

Thirdly, I will and bequeath to the four sons John, Bayliss, George, and Eli of my son Joshua Upchurch, deceased my negro boy Avil, to be equally divided among them.

Fourthly, I will and bequeath to the three sons, William, Jesse, and Thomas of my daughter Catherine Darnell all of my land on the south side of the beaver dam creek except twenty acres on the north end of the tract of thirty acres and also the M. Campbell tract consisting of one hundred and eighty acres, and also the negro man named Doctor, and my grand daughter Sarah Jane Yancy (?) to have fifty dollars out of the sale of my personal property.

Sixthly, I will and bequeath to my son David Upchurch three negroes viz one girl Harriett and two boys viz Foster and General and also all the Darnell tract of land except twenty acres in the southwest corner of the tract.

Seventhly, I will and bequeath to the heirs of my son James Jackson Upchurch my

home tract of land, and twenty acres off of the north west end of the tract of thirty acres lying on the south side of Beaverdam Creek and also twenty acres off of the south west corner of the Darnell tract and also my negro boy Issac (?) to be equally divided between all of the heirs of the said James Jackson Upchurch when the youngest becomes of age but to be cultivated and used until that time by the said James J. Upchurch for his and his families support.

Eighthly, I will and bequeath to my negro woman Sophia, her freedom after my death so far as the laws of the State of Tennessee will permit and to live with one of my sons Jesse or David as she may choose and to be given a wheel, cards, and loom for her to work upon for herself.

Crossed out in the Will:

Ninthly, and all my other property not specified in the foregoing bequests to be sold and the proceeds equally divided among all my heirs according to law.

Lastly, I do hereby nominate and appoint my sons Jesse Upchurch and David Upchurch my executors. In witness whereof I do, to this my last will and testament set my hand and seal this 30th day of April 1853.
