Re: Happy Shaw Tim reports that her family may have been Quakers and have lived in Guilford Co., NC. He thinks it is possible she was "disowned" by her Quaker faith for marrying **John Upchurch**, **VII** outside of her faith. Tim bases this on the fact that Elizabeth Shaw, daughter of Benjamin Shaw and Rhoda -----, was disowned about a month after the marriage of Happy Shaw and **John Upchurch VII**. [Tim's speculation is based on the Assumption that "Happy" may have been a nickname for Elizabeth. However, Tim says he needs more information----RPU 13 Nov 2000].

RPU Note: The land involved no doubt is close to Shaddocks Creek and the Wake Chatham Border where John Upchurch, III lived and died circa 1795 and where his sons owned land. I am a little surprised that these two Upchurches are being cited as late as 1837 as I thought they cleared out of the area in the 1800 - 1820 - 23 Jan 2011
