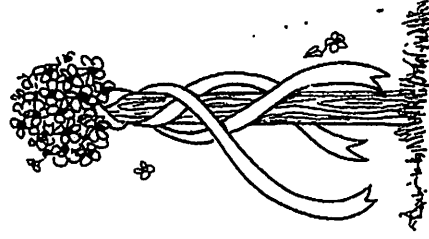

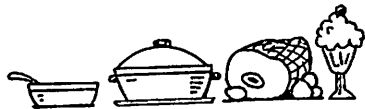

humiliated for the rest of his life. The misguided man had no intention of real wrong-doing, but there seemed no way out once he was in.

If you ever speculate, speculate only on half of your surplus money. In other words, suppose you have ten thousand dollars that you are not using in your business, and your business didn't really need this money, then put only five thousand of this money in your purchase, keeping the other five thousand to hedge with. Don't buy today and sell tomorrow, or next week and think you can do anything but take a loss. Nine times out of ten, those sharpers on the exchange will outwit you and get your money. Now if the market goes too low, start figuring and see what the ten-year average was in the product you are buying. If it is well below the ten-year average, buying or selling, then keep your five thousand dollars for the margin. Stay with it, don't get discouraged and sell out or buy more. Some day the market will go your way. Then when you can realize a good profit take it. Don't think you can make all the profit at once. I have seen fellows hold to the breaking point and when the market was just ready to go their way become discouraged, close out and take a loss. What speculation I have done, I did it as a man would purchase a piece of land, not expecting to sell in the next week, or maybe in the next year or two. Some day it will come in the market at a higher price.

Under no consideration borrow money to speculate on, and don't use any money of your own that is needed in your business. Don't speculate to the extent that if you lose, it would cripple you. It is a very dangerous thing unless you are well on your feet. There are a great many people who believe the market is going their way so strongly, that they make a purchase when there is really no reason in their judgment. Look well at both sides and see what the possibilities of get-

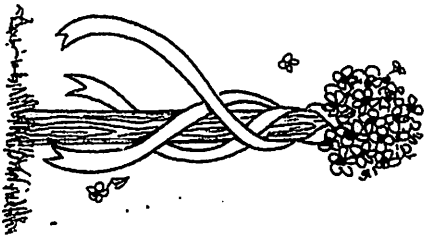

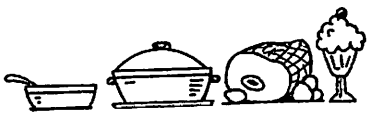

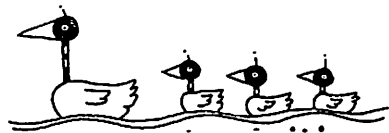

ting the other way are. I have speculated some in my life, but have only taken one loss in all my dealings, that being a very small one. I have renewed my contracts from time to time, held on to them a year or two. but if I had been using the money needed in my business, or put it all up for the first purchase, I would have had to take my loss many times when the market went against me.

Now, children, I want to give you a little advice as to endorsing notes and lending money to your relatives and friends. It has cost me not less than forty thousand dollars in my life, and I lost most all of the friends whom I had befriended with a loan. Also my relatives thought hard of me, or I of them, when I had to force a collection. When I got to the place I could not collect it, which was usually the case, and they showed no disposition to care whether the account was collected or not, then I thought hard. When you have money to loan, it is better to loan it to some business concern and leave the friendship entirely out. Don't indorse notes without ample security for your indorsement. This is hard to do, but if you want to save your money and friends, it is best to do it. I am speaking from actual experience. I have had many a fellow to come to me and inform me he could get what money he needed if I would just put my name on the back of the note. But when I did write my name I usually had to pay the note—and often at a big sacrifice, when I needed the money for other purposes. It is the natural thing to want to help your friends when they are in a hard place, and too, when they can show you that the loan is only for a short time. The money is just around the corner. Most people will pay the bank or big corporation twice as quickly as they will pay an individual. One of my friends told me of loaning a young fellow who was a kinsman some money to fit him for graduation at a school closing. This friend

about it than he does, but do not give him advice unless he asks for it. Don't consider a little work overtime out of the question, or go by the watch too much. Though through divers paths we're lead.

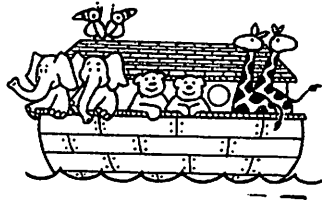
May we hope for more reunions,

 Will I reach port in safety at close of the day?

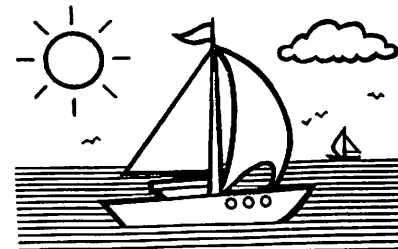
Many a boat has pulled out from shore,

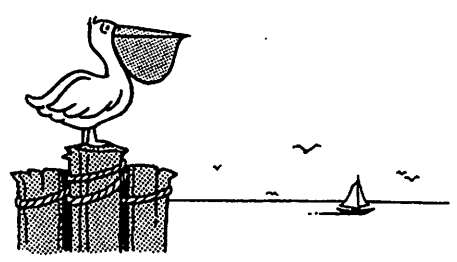

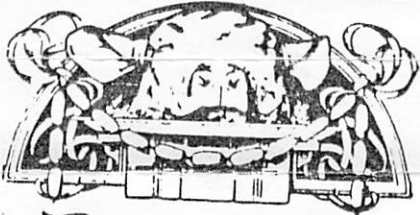
