## **Thomas L Upchurch**

#### XID - 4325

**Commentary:** Thomas L. Upchurch was the son of Samuel and Mary Ellen Simmons Upchurch, and the grandson of John III, head of Upchurch Clan 14. Born in Tennessee, he accompanied his family to Illinois. It was there that he and two of his brothers served in the Black Hawk War in 1832.

Robert Franklin Upchurch recalled in later life and wrote of the hardships his mother suffered as a young widow with 2 small children. She went to live with her mother on a tract of land her parents had bought when they moved to IL in 1864. This tract was later sold to Hiram Lewis Upchurch who passed it to William Herman Upchurch. It was on this tract of land that **Thomas L Upchurch** died.

# THOMAS L. UPCHURCH FAMILY (9)

Thomas and his wife Mary Davis Upchurch were born in TN. The first record found in IL is where he became a member of the Bethel Creek Church by letter in Oct. 1834. Thomas was a signer of a petition which was made between 1836 (when Galatia was laid out) and 1847 (when Saline Co. was separated from Gallatin Co.) The petition was to the effect that the voters were asking that the place of voting be changed from the house of Thomas Gasaway to the town of Galatia. Among the signers were: Thomas Upchurch, David Smith, David Upchurch, William Upchurch, Samuel Upchurch and John Upchurch. The petition was addressed to Honorable County Commissioner's Court of Gallatin County.

From records available it was found that Thomas and 'Polly' had ten children. These are from census records, tombstones, marriages and probate records in Saline Co. Thomas L. Upchurch estate was entered for probate 11-16-1874, his sons Joseph C. and Samuel R. were the appointed administrators. The children:

#### Learned from the Deed

Children #1, 2, 12 not mentioned – hence presumed deceased with no heirs.

= Names confirmed by the deed

For John Upchurch #4, his wife is listed (twice) as Katharine Upchurch, hence nee Katharine Johnson\*

For William L Upchurch (#5) – no wife is listed so he may have been between wives

For Nancy Upchurch (#8) she appears as Nancy Cantrell but no husband is listed; presume he is deceased (He is.)

For Thomas L Upchurch - no wife listed - presumably because he is buying the property

For Elizabeth Upchurch (#11) – her husband is shown clearly as Charles Thompson (not Joseph Thompson)

A History of Saline County, FL 1847 – 1947 shows John Upchurch, Thomas Upchurch [<u>TLU</u>] and Jonathan Upchurch served in the Black Hawk War. [These 3 are presumed sons of Samuel Upchurch and grandson of John Upchurch, III – Head of Clan – RPU]

John Upchurch, Jonathan Upchurch and Thomas Upchurch (3 brothers) were in Lower Franklin Co, IL. They were all in the 1<sup>st</sup> Regiment, 1<sup>st</sup> Brigade, 3<sup>rd</sup> Army Captain, Coffey Co under Gen Henry Atkinson [Black Hawk War]. All three mustered out 12 Aug 1832 (DEU clarified to RPU 31 Aug 1983).

[Note: John Upchurch and Jonathan appear to be sons of Samuel Upchurch – need work on Thomas – RPU]

(9) In the Black Hawk Indian War of 1832 in IL, the following were in Capt Archilles Coffey's Co, 1<sup>st</sup> Regiment, 1<sup>st</sup> Brigade, IL Mounted Volunteer: John Upchurch, Jonathan Upchurch and **Thomas Upchurch**.
