Dear Cousin Jo Ellen,

I have just finished several projects related to the Elliott Vernon & Family including your letter of 5 MAR 95 and your sisters of 17 JAN 1995. Input from several directions has allowed continued improvement in the Master Outline for this family. A copy of the 19 page version as it now stands is enclosed for your use.

Thank you for the ~~two~~ \$50 check as a memorial to your mother and for use in the research on the Yelburch Family. The memorial appeared in UB Vol 1 No 1 which issued recently. We used the spelling JACQUETINE as given in your 5 MAR 1995 letter. Now that I have reviewed all references to this name it appears it should have been JACQUELINE. Could you let me know the preferred spelling. If I got it wrong, I apologize.

There are a few missing items on your mother's family as indicated on the enclosed

sheet. I realize now might not be the time to get these details but perhaps there will come a time.

Enclosed is a copy of the registration list for the 1994 Upchurch Reunion in Oklahoma City. My notes have been added. If you have not corresponded with your Aunt Verna, you might wish to do so. She has been very helpful on family history. Two of your first cousins who have been helpful are Fran Esch and Verna Hope.

If there are other aspects of your family history you would like to explore, please let me know. If you are so inclined it would be great if you and Jane would collaborate to prepare a formal statement on your recollections of your mother along with pertinent facts.
