GRANDMOTHER TOLD US.....

↳ [AMARILLA JANE WHITE SIDE

Grandmother's mother, Mary Ann (Upchurch) Whiteside, was the oldest daughter of David Upchurch. Prior to her marriage she lived on the family farm, the Wayside Inn. The late Phil Upchurch of Galatia told me that he had been told that the inn was located about one block north of his grandfather Gratton's home, (the site of the present bank in Galatia) on the old State Road or trail from Shawneetown to Kaskaskia.

David Upchurch is usually mentioned as being a public official and a farmer, but he was also an excellent cabinet maker. The late Phil Upchurch had a beautiful chest of drawers in his home made by David Upchurch before his death in 1855.

Mary Ann Whiteside died in 1858 and is buried at Brooks Cemetery just west of Galatia. Her husband William Whiteside was a native of the present Saline County and the son of Thomas and Sarah (McCreary) Whiteside, natives of Warren and Clark Counties, Kentucky, respectively. He was left with three young daughters to rear: Amarilla Clementine (Aunt) age 13 years, Jane age 10 years, and Margaret Mahaley (Meg) age 5 years. William and his brother Lewis were owners and operators of saw mills in the west part of Saline County. After the death of Mary Ann, William decided to sell out and move his family to Arkansas. He was able to persuade Lewis to do the same. A third family went with them.

I asked Aunt Rachel Barber, Grandmother's youngest child, why Great Grandfather would leave Saline County and take the children to an unsettled country, when the relatives were nearby. Her answer was that he thought it was becoming too populated and he liked the wide spaces. She also told me that Grandmother had told her, "the Whiteside men were much better hunters than farmers, and were known for their fine riding horses and hunting rifles, and were not afraid of anything--man or beast."

This is what Grandmother told us children about the trip to Arkansas and the results. Grandmother died in 1929, the other two sisters were already deceased.

In 1859 or early 1860 the three families left Galatia for Arkansas. There were three large covered wagons with the cows tied behind the wagons. The two Whiteside wagons were pulled by horses while the third wagon was pulled by a yoke of oxen. Aunt Ann and Grandmother and a cousin were allowed to ride their father's saddle horses all the way to their new home. Grandmother, being the youngest of the three, felt very grown up and just as large as her sister and cousin. The girls were told by their fathers to keep close to the wagons, and to not lag behind as it might be dangerous. According to Grandmother the trip was very ordinary.

Like all children we wanted to know if Grandmother had any experiences with wild animals. Nothing--except the cries of wild-cats and panthers were common. She did tell us about the experiences of two women of her acquaintance.

The location of the homestead in Arkansas is not known at present, but it was very isolated and in dense timber. [THEY WERE ON 1860 CONWAY CO, AR CENSUS]

The Civil War broke out and in the early part of 1862 Great Grandfather Whiteside enlisted in the Confederate Army. (According to the National Archives he enlisted in Conway County, Arkansas in Co. C of 51st Confederate Infantry.) He served as a sergeant in his outfit and became ill, while fighting in western Tennessee, and was left behind by his company--since he was too ill to travel. A farmer took him in his home and cared for him until his death and then buried him. Then he sent a letter to the daughters along with their father's personal effects. Both men were Masons. Aunt Ann was the oldest child and she had the family Bible and the letter in her care. Over the years the letter has disappeared, but the Bible is now in the possession of her great grand daughter in Roxton, Texas.

Grandmother never had anything good to say about the Confederate or Union Army. She disliked both intensely. She always maintained her father had been forced to enlist in the Confederate Army. (From what I have read, I think Grandmother was correct about his being forced to enlist or else.....)

When their father entered the service, he made arrangements for a black couple to live with and care for the children. Something happened to the couple and suddenly the children were left on their own. The War lasted three more years. Their cabin was raided frequently by both Armies. The soldiers, as Grandmother said, "stole every thing they could get their hands on and even took their bayonets and stuck them in the ground of the smoke house looking for buried meat." The girls soon had lost their horses, hogs, chickens, and all their food. They became so hungry for salt that they scraped up the salt and dirt on the smoke house floor to use. Grandmother thought they might have starved but they were able to keep one milk cow hidden in the cane brake from the soldiers. The girls took turns staying in the cane brake and caring for the cow.

The girls had the care of their father's fine hunting rifle when he left. After the raiding began they decided to hide the gun away from the cabin. It was carefully wrapped in oiled paper and taken into the deep woods. A large hollow tree was found and the gun hidden in the tree. A large log was nearby. Aunt and Jane thought they had the location marked firmly in their minds- but after the War they could never find the right tree- or the gun.

Part of the time the girls were in the home of Lewis Whiteside. He joined the Union Army during the latter part of the War. He was in the 3rd Arl. Cav. Co. B. His wife was the former Louisa Jones, daughter of Nathaniel & Rachel (Anderson) Jones, early settlers of the Saline-Franklin County area of Southern Illinois. It was fortunate that Lewis did not have to fight against his own brother.

After the War Lewis decided the orphans should return to Southern Illinois as there were more relatives here to care for them. When the girls went to purchase their fares on the steamboat to Shawneetown, they had only enough money to buy two tickets. Meg was wearing her father's Masonic pin on her dress and the captain of the boat was kind enough to let her ride on the boat free. He was wearing a Masonic ring.

Arrangements were made for the girls to go to the home of their aunt and uncle in South Twigg Township of Hamilton County. Emily and John Lane had ten children of their own and three more were just too many. So the girls were placed in homes around Galatia and Raleigh to work for their "keep". This they did until they married. None had an easy life.

Aunt Ama married James Beaver in 1869 and they made their home in Arkansas. Grandmother, Jane, married James B. Irvin in 1870 and later they were divorced. She then married a widower, George Barter of the Barter settlement just over the Williamson County line. The youngest daughter, Aunt Meg, married Oscar Irvin in 1873. This couple lived in Galatia and both died there and are buried at Brocks Cemetery. He was a shoe repairman. Their grandchildren live in Galatia at the present time.

Grandmother never expected any sympathy or pity- it was just life.

After Mary Ann U died in 1858 leaving 3 young girls William Whiteside and his brother Lewis Whiteside moved their families to Conway Co, AR where they are found on the 1860 census. William was killed in the Civil War and the girls were partially in the care of their Uncle Lewis Whiteside who was LOUISA JONES, dau of Nathaniel Jones & Rachel Anderson, early settlers of the Saline-Franklin Co Area of Southern Illinois. After the war Lewis returned the 3 girls to IL and they were initially placed in the home of their Aunt & Uncle EMILY and JOHN LANE in the South Twigg TSP of Hamilton Co, IL. However, as Emily & John had 10 children of their own the 3 girls were placed in homes around Galatia & Raleigh, IL to work for their "keep".

[NOTE: Need to establish if EMILY is the same as Margaret E. U, a sister of Mary Ann U - otherwise EMILY has to be a sister of William & Lewis Whiteside & thus see EMILY WHITESIDE - RPU]

The girls had the care of their father's fine hunting rifle when he left. After the raiding began they decided to hide the gun away from the cabin. It was carefully wrapped in oiled paper and taken into the deep woods. A large hollow tree was found and the gun hidden in the tree. A large log was nearby. Ama and Jane thought they had the location marked firmly in their minds- but after the War they could never find the right tree- or the gun.

Part of the time the girls were in the home of Lewis Whiteside. He joined the Union Army during the latter part of the War. He was in the 3rd Arl. Cav. Co. B. His wife was the former Louisa Jones, daughter of Nathaniel & Rachel (Anderson) Jones, early settlers of the Saline-Franklin County area of Southern Illinois. It was fortunate that Lewis did not have to fight against his own brother.

After the War Lewis decided the orphans should return to Southern Illinois as there were more relatives here to care for them. When the girls went to purchase their fares on the steamboat to Shawneetown, they had only enough money to buy two tickets. Meg was wearing her father's Masonic pin on her dress and the captain of the boat was kind enough to let her ride on the boat free. He was wearing a Masonic ring.

Children of Mary Ann Whiteside (14) - DAUGHTER OF DAVID U

William Whiteside, husband of Mary Ann (Upchurch) was a farmer and a timber man. He and his brother operated sawmills. After the death of Mary Ann in 1858, he decided to move his family to Arkansas and persuaded his brother Lewis Whiteside and his family to go with him. They started for AR in three covered wagons, two drawn by horses, the other by oxen. The two oldest daughters of William and their cousin, oldest child of Lewis Whiteside, rode the saddle horses to Arkansas.

(As told to Mary Afton Anderson by her grandmother) "I remember how important my grandmother said she felt to be allowed to ride horseback. She was the youngest of the three. It has not been determined where they settled in AR, but it was isolated and heavily wooded. In January of 1862 William Whiteside was forced to enlist in the Confederate Army, so grandmother always said. My grandmother never had any use for for the Union or Confederate armies. William Whiteside was enlisted in Conway Co. AR, according to information from the National Archives. He was a sergeant in C Co., of the 31st Infantry. He became ill, was not able to travel with his outfit, and was left behind. A fellow member of the Masonic Lodge took him in and cared for him until his death, then buried him. He wrote to William's children after the death, sent them their father's Bible and personal effects. The oldest daughter had the privilege of caring for the Bible and the letter. Over the years the letter was lost. For awhile, after William was in the Army, a negro couple took care of the three girls, but eventually they were in the home of Lewis Whiteside and his wife. In the meantime, Lewis was able to join the Arkansas Cavalry, Union. So one brother fought on the Union side, the other fought on the Confederate side. During the war my grandmother and her sisters had a difficult time surviving. They were constantly raided by both North and South armies. They managed to keep one milk cow from the raiders, the girls took turns staying with the cow in the tall cane brake, so she would not be found. After the war, Lewis felt it best to return the girls to IL as there were more relatives there. They came back by steamboat to Shawneetown, having only enough cash to pay for two fares. Meg, the youngest, wore her father's Masonic pin on her dress. The Captain of the boat felt sorry for her and let her come on the boat free. The girls had a difficult time but all survived married and reared families."

GRANDMOTHER TOLD US.....

↳ [GARRILLA JANE WHITESIDE

Grandmother's mother, Mary Ann (Upchurch) Whiteside, was the oldest daughter of David Upchurch. Prior to her marriage she lived on the family farm, the Wayside Inn. The late Phil Upchurch of Galatia told me that he had been told that the inn was located about one block north of his grandfather Gratton's home, (the site of the present bank in Galatia) on the old State Road or trail from Shawneetown to Kaskaskia.

David Upchurch is usually mentioned as being a public official and a farmer, but he was also an excellent cabinet maker. The late Phil Upchurch had a beautiful chest of drawers in his home made by David Upchurch before his death in 1855.

Mary Ann Whiteside died in 1858 and is buried at Brooks Cemetery just west of Galatia. Her husband William Whiteside was a native of the present Saline County and the son of Thomas and Sarah (McCreary) Whiteside, natives of Warren and Clark Counties, Kentucky, respectively. He was left with three young daughters to rear: Annrilla Clementine (Ama) age 13 years, Jane age 10 years, and Margaret Mahaley (Meg) age 5 years. William and his brother Lewis were owners and operators of saw mills in the west part of Saline County. After the death of Mary Ann, William decided to sell out and move his family to Arkansas. He was able to persuade Lewis to do the same. A third family went with them.

I asked Aunt Rachel Barter, Grandmother's youngest child, why Great Grandfather would leave Saline County and take the children to an unsettled country, when the relatives were nearby. Her answer was that he thought it was becoming too populated and he liked the wide spaces. She also told me that Grandmother had told her, "the Whiteside men were much better hunters than farmers, and were known for their fine riding horses and hunting rifles, and were not afraid of anything-man or beast."

This is what Grandmother told us children about the trip to Arkansas and the results. Grandmother died in 1929, the other two sisters were already deceased.

In 1859 or early 1860 the three families left Galatia for Arkansas. There were three large covered wagons with the cows tied behind the wagons. The two Whiteside wagons were pulled by horses while the third wagon was pulled by a yoke of oxen. Aunt Ama and Grandmother and a cousin were allowed to ride their father's saddle horses all the way to their new home. Grandmother, being the youngest of the three, felt very grown up and just as large as her sister and cousin. The girls were told by their fathers to keep close to the wagons, and to not lag behind as it might be dangerous. According to Grandmother the trip was very ordinary.

Like all children we wanted to know if Grandmother had any experiences with wild animals. Nothing- except the cries of wild-cats and panthers were common. She did tell us about the experiences of two women of her acquaintance.

The location of the homestead in Arkansas is not known at present, but it was very isolated and in dense timber. [THEY WERE ON 1860 CONWAY CO, AR CENSUS]

The Civil War broke out and in the early part of 1862 Great Grandfather Whiteside enlisted in the Confederate Army. (According to the National Archives he enlisted in Conway County, Arkansas in Co. C of 51st Confederate Infantry.) He served as a sergeant in his outfit and became ill, while fighting in western Tennessee, and was left behind by his company- since he was too ill to travel. A farmer took him in his home and cared for him until his death and then buried him. Then he sent a letter to the daughters along with their father's personal effects. Both men were Masons. Aunt Ama was the oldest child and she had the family Bible and the letter in her care. Over the years the letter has disappeared, but the Bible is now in the possession of her great grand daughter in Roxton, Texas.

③ CONTINUED

Grandmother never had anything good to say about the Confederate or Union Army. She disliked both intensely. She always maintained her father had been forced to enlist in the Confederate Army. (From what I have read, I think Grandmother was correct about his being forced to enlist or else.....)

When their father entered the service, he made arrangements for a black couple to live with and care for the children. Something happened to the couple and suddenly the children were left on their own. The War lasted three more years. Their cabin was raided frequently by both Armies. The soldiers, as Grandmother said, "stole every thing they could get their hands on and even took their bayonets and stuck them in the ground of the smoke house looking for buried meat." The girls soon had lost their horses, hogs, chickens, and all their food. They became so hungry for salt that they scraped up the salt and dirt on the smoke house floor to use. Grandmother thought they might have ~~survived~~ but they were able to keep one milk cow hidden in the cane brake from the soldiers. The girls took turns staying in the cane brake and caring for the cow.

The girls had the care of their father's fine hunting rifle when he left. After the raiding began they decided to hide the gun away from the cabin. It was carefully wrapped in oiled paper and taken into the deep woods. A large hollow tree was found and the gun hidden in the tree. A large log was nearby. Ama and Jane thought they had the location marked firmly in their minds- but after the War they could never find the right tree- or the gun.

Part of the time the girls were in the home of Lewis Whiteside. He joined the Union Army during the latter part of the War. He was in the 3rd Arl. Cav. Co. B. His wife was the former Louisa Jones, daughter of Nathaniel & Rachel (Anderson) Jones, early settlers of the Saline-Franklin County area of Southern Illinois. It was fortunate that Lewis did not have to fight against his own brother.

After the War Lewis decided the orphans should return to Southern Illinois as there were more relatives here to care for them. When the girls went to purchase their fares on the steamboat to Shawneetown, they had only enough money to buy two tickets. Meg was wearing her father's Masonic pin on her dress and the captain of the boat was kind enough to let her ride on the boat free. He was wearing a Masonic ring.

Arrangements were made for the girls to go to the home of their aunt and uncle in South Twigg Township of Hamilton County. Emily and John Lane had ten children of their own and three more were just too many. So the girls were placed in homes around Galatia and Raleigh to work for their "keep". This they did until they married. None had an easy life.

Aunt Ama married James Beaver in 1869 and they made their home in Arkansas. Grandmother, Jane, married James B. Irvin in 1870 and later they were divorced. She then married a widower, George Barter of the Barter settlement just over the Williamson County line. The youngest daughter, Aunt Meg, married Oscar Irvin in 1873. This couple lived in Galatia and both died there and are buried at Brooks Cemetery. He was a shoe repairman. Their grandchildren live in Galatia at the present time.

Grandmother never expected any sympathy or pity- it was just life.
