There is no documentary proof of the parentage of WILLIAM and RICHARD UPCHURCH, who appeared in the 1755 Tax List of Granville County, N. C., but judging from circumstances they must have been older sons of JAMES UPCHURCH I of Brunswick County, Va. JAMES named "his younger son, MIAL", in his will proved in Brunswick in 1765. (See abstract of will of JAMES UPCHURCH in PART TWO). No record has been found of a purchase of land by WILLIAM or RICHARD to account for their name's appearance on the Granville, N. C. Tax List.

On the 28th of May, 1778, WILLIAM applied for a land grant in Granville County. 300 acres were granted to him on the 1st of March, 1780—"on the waters of Fishing Creek." This creek runs north and south and lies just south of the present city of Oxford, N.C. (N. C. LAND GRANTS, BK 35/255).

In 1769 WILLIAM UPCHURCH, Jr., presumably a son of WILLIAM above, was listed for taxes in Granville County. JOHN UPCHURCH, probably another son of WILLIAM, Sr. gave his Oath of Allegiance in Granville in 1778. WILLIAM, Jr., gave his oath in 1788.

On the 5th of August, 1779, WILLIAM UPCHURCH applied for an additional land grant. This was issued to him on the 15th of October 200 acres "on the waters of Buckhorn Creek", in Granville County.

On the 26th of August, 1782, WILLIAM UPCHURCH, Sr., sold to WILLIAM, Jr., 300 acres—"on Fishing Creek." (Recorded at Nov. Court of 1783—GRANVILLE CO., N. C. DEED BK 0/263).

On the 9th of December, 1785, WILLIAM UPCHURCH sold 200 acres of land for £30 to Samuel Jones—"on waters of Buckhorn Creek." (GRANVILLE CO., N. C. DEED BK 0/462).

Many of the descendants of WILLIAM UPCHURCH continued to live in Granville County, and have taken an active part through the years in church and civic affairs of Oxford, N. C., the County seat. With regret I am unable to include these descendants in this volume.

Recorded 8-26-1875. Not included as William 1, 2, etc., is the William Upchurch of Virginia. He lived in the Sixth District of Brunswick County, seemed to own no land. He paid Personal Property taxes from the year they began and paid his last tax in 1790. Nfi.

William (1) was listed in Granville, Oxford District on the State Census taken 1786 and on the Federal Census of 1800 in the same district. The ages of William and his two sons may now be estimated. Assuming William (1) was born in 1735 (son of James who died in 1765) his age in 1786 was 51 (listed as over 21). His two sons were under 21 years of age.



Prior reviews have concluded that the William Upchurch above is **William U, II (XID 161)** – a 4th generation Upchurch and son of James Upchurch, I.

The only John Upchurch on the current master outline of the first six generations of Upchurches in America that would fit a John U (A) to sign an oath on 30 May 1778, would be John U, III (XID 157) – head of Upchurch Clan 14, and son of James U, III. He had previously lived in VA and later was in Chatham Co. NC but this is the first placing him in Granville Co. NC. Is this placement valid?



As to a second John U (B), John U, I and John U, II d<1778, John U, IV was not old enough to have signed an other in 1778. If John U exists he is not the 6 Generation Chart and must be a new 4th or 5th generation Upchurch.

Granville Co. NC was formed in 1746 from Edgecombe Co. NC as a singe parish. St John's no (?) area was later added to Granville County, but numerous portions were split off. We believe the portions of old Granville County pertaining to Upchurch history of the 1700s is represented by present day counties of Granville, Franklin, Warren and Vance. These counties in fact represent the bulk of old Granville County.


