UPCHURCH - Shadrack Allen "Shade" Upchurch was born Sept. 18, 1884 to Hiram and Ruth Slaven at Slickford, KY. Shade was a farmer at heart. He served his country in the Union Army 30th KY Regiment. At the

Battle of Mill Springs he was a CPL 5 and was a mounted guard for General Burke, when General Zollicoffer was killed.

When released from the Army, he returned to Slickford to his wife, Celia Morris, and together they had the following children:

William A. Gilreath was born on February 12, 1829 in North Carolina. At present no information is available on his earlier life. He moved to Fentress County between 1840-50. He wo a prominent citizen of the Travisville Community. He ran a grist mill and was a Justice of the Peace in 1891. William also worked for the establishment of Pickett County.
William married Mary Adeline Allen about 1848 as their oldest child Martha is listed as 1 year old in the Fentress County Census Records in 1850 . This is the first year William and Mary appear in the Fentress County Census, along with her parents Augusta and Elina Allen, and shows both the Gilreaths and Allens were born in North Carolina and their daughter Martha born in Tennessee. Mary's only known brother was Lafayette Allen, born in NC about 1843 and living in Tennessee in 1850, who was killed at the Dr. Hale place at Wolf River, TN, while on leave from the army during the Civil War.
William was married three times; (1) Mary Allen, (2) Rhoda Moody Crouch, (3) Necie Upchurch. Some sources indicate a marriage to Margaret Beason. But this writer can find no record of such a marriage.
William and Mary Allen were the parents of four children; Martha E., Elvina Alice, Malissa Adeline, and James.

Martha E., born December 1848, married Joe Crouch. They had two children Belle and Mary, both of whom died while young.
Elvina Alice, born 1852, married Sampson Fowler. Their children were; William Lafayette, Martha, John, James and Minna.
Malissa, born December 7, 1855, married John Wesley Crouch (son of George Washington Crouch and Lucinda Jennings). Their children were: Zona, who married Melvin Davidson; Martha, who married John Marion Rains; James Gordon, who married Ellen Storie and Delta Winningham; Dave, who
married Eva Baker; William Lee, who married Ollie Storie; Fannie, who married Fred Leah; Nellie, who married Lewis Craig; Tom, who married Alta Greer, Necie, who married Otto Garrett; and Ruby, who married John Rushing. Melissa died January 4, 1903. Her husband John died September 4, 1935. They are buried in the Davidson Cemetery at Forbus, TN. Their history can be found elsewhere in this book.
James, born 1861, married Corda Beason. Nor further information available at this time.
Mary Allen Gilreath died September 1866 and her funeral was conducted by Rev. A.B. Wright, at the "Head of the Cane".
Rhoda Moody Crouch became William's second wife sometime before 1880. She was the widow of William Crouch and had several children. William and Rhoda's children were; John, Nancy, Ebadell, and Leander.
John, born 1865, married Fetna Davidson and had Charles, Milton, Lee, Fiona, Nona, Abbe, and Ben.
Nancy, born 1868, married John Evans.
Ebadell, born 1871, married John Upchurch.
Lee, born 1874, married Dovie Smallwood and had no children.
The 1900 Fentress County Census shows William and his third wife Necie Upchurch married 10 years. Their two children were Luther C. and Vannah E.

Luther, born in August, 1892, married Pearl Chism (daughter of L.B. Chism and Mary Wood) $\uparrow$ Their children were Willie, Christina and Hazel. Luther was killed in December, 1915.
Vannie, born December, 1894, married Bill Paris.
William died December 16, 1901 and is buried in the Gilreath Cemetery on his old homeplace.

On September 22, 1779, Timothy Real Medlin was issued a land grant by the State of North Carolina for 200 acres on Buck Branch in Franklin County.

On October 29, 1779, Timothy Real Medlin sold to John Gay 100 acres in Franklin County adjoining land that had been previously owned by Edward Haithcock, Frances Bradley, and Nathaniel Carter.

In 1779, William Owen Medlin (Jr.) was included on a tax list in Wilkes County.
In 1780, Bryan(t) Medlin, Sr., Bryan(t) Medlin, Jr., Benjamin Medlin, Nicholas Medlin, and William (Owen) Medlin, Sr. were listed as taxpayers in Dobbs County. Bryant Medlin, Sr., Bryant Medlin, Jr., and Benjamin Medlin were living in 1780 in Captain John Granger's district of Dobbs County, which included the townships of Contentnea Neck, Vance, and Sandhill, on the north side of the Neuse River, above Kinston, in what became Lenoir County in 1791.

As best as can be determined from inconsistent census data, Bryant Medlin, Jr. must have been born around 1764, probably in Bute (Franklin) County, North Carolina.

In 1781, Timothy Ryal Medlin purchased land from Abraham Rogers in Franklin County.

On March 30, 1784, Bryant Medlin (Jr.) bought 150 acres of land from Benjamin Sellers on the north side of Bawdy Swamp in Johnston County, adjacent to Colonel Williams, John Whitley, Joseph Edwards, and Richard Warren, the sale of which was witnessed by Benjamin Medlin and Benjamin Williams, Jr.

On September 14, 1784, Bryant Medlin sold 150 acres on the north side of Bawdy Swamp in Johnston County to Richard Warren, witnessed by Benjamin Medlin. Both of these deeds were admitted into Johnston County Court records on December 2, 1784, with Needham Bryant, William Avera, and Richard Warren present as justices.

In 1784, Bryan (t) Medlin (Jr.) and Nicholas Medlin were listed as taxpayers in Johnston County in Captain Joseph Boon's Company.

On September 9, 1784, in Moore County, Joel Medlin entered 100 acres on south side of Lower Little River bordering Robert Smith.

Thanks so much for clarifying my Upchurch line. I now have my Upchurch, Peacock, and Box lines back to England. I am missing one link.

I , and others have been looking for "Mr. Elusive Woods" for years and years. He is the grandfather of Joseph Richard Woods (wife-Charlie Belle Upchurch).

His widow, Elizabeth Fowler Woods shows up in the 1850 Choctaw County census as a widow with eight children. Her youngest is two. This means her husband disappeared around 1848. We have Elizabeth well documented, but we have never been able to ascertain her husbands identity. Since Elizabeth's oldest son Stephen was born in Marion County Al. I suspect that "Mr. Elusive" was James Woods but no proof. Also strange is that Elizabeth's second husband was James B. WOOD, her next door neighbor. This makes me kin to all of the WOOD clan in Choctaw County.
