I wrote to a Mrs. Avlyn Dodd Conley, who works on the Darnell family,

I also asked her about the Celia Darnal (b. 12 June 1784; d. 27 Apr. 1852) buried in the Upchurch Cemetery in Henry Co., TN

About Celia, she said that she was the wife of Nicholas Darnall, Sr. (father of Thomas L. Darnell <6241>) and had been named as said wife in Nicholas' Will in Henry Co., Tn.

"Celia Darnell will. To Mary Jane Aycock (formerly Mary Jane Upchurch) to have negro girl. To Celia Elizabeth Wynns (formerly C. E. Upchurch) to have negro. To Bayliss House Upchurch have negro. To John F. (not 21 years of age) and George W. Upchurch to have negroes. To Eli Upchurch a negro girl. To Jennetta Darnell for life certain property. Appoints Thomas J. Wynns and Jordan T. Aycock executors. 10 May 1848 (Wills 1844-56, p. 433)" HENRY CO, TN

This seems to indicate that Celia Darnell was closer to the Upchurches than just mother-in-law of Jeanette Darnell. In fact, it seems to say that she was closer to the Upchurch side of the family than to the children of her husband whom are not even mentioned in her Will.

All of the Upchurches listed in her will are (purportedly) children of Joshua U. and Jeanette -- although I sure wish I could find proof of that in the case of Celia Elizabeth U. who married Thomas Jefferson Wynns (which is one of my lines). John U.'s Will (dated 1853, prob. 1854) names four sons of his deceased son Joshua, as John, Bayless, George and Eli, which is the same 4 males as in Celia Darnell's Will (who died in 1852). John's Will further says "and the five remaining heirs of my son Joshua Upchurch dec'd." Does this mean that there were only 5 still alive or that there were 5 more besides the ones that he'd named?

In 1850, Jeanette Upchurch Darnell, John F., Bayliss, G. W. and Eli Upchurch were in household of Thomas L. Darnell as was Celia Darnell <Household #115-Dist. #16>. Celia Upchurch Wynns was in household of Thomas Jefferson Wynns (with a 6 mo. girl named Jennette) <Household #116-Dist. #16>. Mary Jane was in household of Jordan T. Aycock <Household #58-Dist. #1>

In 1860, I find in D#1856, Jennetta Darnell and George Upchurch; D#1969, John F. Upchurch and his family; D#1950, Bayliss Upchurch and his family; D#1833, Celia E. Wynns in household of Thomas J. Wynns - don't find Eli Upchurch or Mary Jane and Jordan Aycock.

I guess Mary Jane could have died after the writing of Celia's will and before John's will, making Celia, John, Bayliss, Eli and George the five remaining children of Joshua. I guess the first thing I need to do is see if I can get a copy of a Will for Joshua. Then be on the lookout for a marriage between Nicholas Darnell and a Celia which may give me a clue as to who Jennette is.

Avlyn Conley indicated that the Darnell family had been in Marshall Co., Ky. earlier.

To John F. (not 21 years of age) and George W. Upchurch to have negroes. To Eli Upchurch a negro girl. To Jennetta Darnell for life certain property. Appoints Thomas J. Wynns and Jordan T. Aycock executors. 10 May 1848 (Wills 1844-56, p. 433) HENRY CO, TN

This seems to indicate that Celia Darnell was closer to the Upchurches than just mother-in-law of Jeanette Darnell. In fact, it seems to say that she was closer to the Upchurch side of the family than to the children of her husband whom are not even mentioned in her Will.

All of the Upchurches listed in her will are (purportedly) children of Joshua U. and Jeanette -- although I sure wish I could find proof of that in the case of Celia Elizabeth U. who married Thomas Jefferson Wynns (which is one of my lines). John U.'s Will (dated 1853, prob. 1854) names four sons of his deceased son Joshua, as John, Bayless, George and Eli, which is the same 4 males as in Celia Darnell's Will (who died in 1852). John's Will further says "and the five remaining heirs of my son Joshua Upchurch dec'd." Does this mean that there were only 5 still alive or that there were 5 more besides the ones that he'd named?

In 1850, Jeanette Upchurch Darnell, John F., Bayliss, G. W. and Eli Upchurch were in household of Thomas L. Darnell as was Celia Darnell <Household #115-Dist. #16>. Celia Upchurch Wynns was in household of Thomas Jefferson Wynns (with a 6 mo. girl named Jennette) <Household #116-Dist. #16>. Mary Jane was in household of Jordan T. Aycock <Household #58-Dist. #1>

In 1860, I find in D#1856, Jennetta Darnell and George Upchurch; D#1969, John F. Upchurch and his family; D#1950, Bayliss Upchurch and his family; D#1833, Celia E. Wynns in household of Thomas J. Wynns - don't find Eli Upchurch or Mary Jane and Jordan Aycock.

I guess Mary Jane could have died after the writing of Celia's will and before John's will, making Celia, John, Bayliss, Eli and George the five remaining children of Joshua. I guess the first thing I need to do is see if I can get a copy of a Will for Joshua. Then be on the lookout for a marriage between Nicholas Darnell and a Celia which may give me a clue as to who Jennette is.

Avlyn Conley indicated that the Darnell family had been in Marshall Co., Ky. earlier.

I found in my mother's notes that someone told her that Joshua's wife was a House. I haven't found proof of that as yet. There were several House families around Henry and Stewart Cos., including one named John Bayliss House. Joshua and Jennette have a son named Bayliss House U. So it appears logical, but I haven't found a family to fit her into as yet.

6. Celia Elizabeth - Although I've heard lots of stories about her son Joshua Wynns who married Zenobia Bradford Upchurch, I was about convinced that he didn't really exist. I couldn't find any record of him in any of the census records. Then finally in the 1900 census I found William J. Wynns in the household of Zenobe Upchurch and suddenly a light bulb exploded in my head. He'd been right in my records all of the time, but as William J. rather than as Joshua. I still want to find the marriage record to verify that an actual marriage really did take place. Zenobia's tombstone lists her as an Upchurch rather than as a Wynns, however, that could just have something to do with the husband that she lived with longest and by whom she had children.

7. Bayliss House - in "History of Henry Co. Commands" it states that Ballus H. Upchurch was killed at the Battle of Athens, Alabama, 10 May 1864. I have not been able to find a reference to this battle in any Civil War books that I've looked in. So don't know if this was in error or not. I need to find a listing of battles by date to see what battles are listed for that date.

9. Joshua - I notice that you have him listed as a son of Joshua. Sounds good to me, but I don't know how to prove it. He would have been born about 3 months after Joshua's death, so it appears logical that his mother would name him after his deceased father. Since he only lived from 1845 to 1847 he won't show up in any census.
